The Neighborhood STAR program has been a huge benefit to St. Paul neighborhoods. I admire the model of citizen review supported by PED expertise and would like to be a part of it. Quite honestly, I admire how the program was authored, how project criteria were set up to set aside a

revenue stream, to maximize the leverage of that public money and improve the tax base and to intentionally balance benefit around the city.

**What skills/training or experience do you possess for the committee(s) for which you seek appointment?**

In my 24 years in my chosen city, I have lived or worked in every Ward except Ward 6 and I have family there. I'm sure that applies to many of us but I mention it because I have experienced the strengths and needs of many of our neighborhoods first hand as a renter, homeowner, student, and worker.

I have also served as a volunteer and board member of the Riverview Economic Development Association (REDA), now merged with Neighborhood Development Alliance (NeDA). REDA was a business association and community development corporation committed to improving the quality of life in St. Paul's West Side neighborhood by building local business capacity and amenities. My experience with REDA gave me the opportunity to critically evaluate the benefits and trade-offs involved in brick and mortar projects as measured against our mission.

Finally, I am also a graduate student in the Master of Public and Non-Profit Administration program at Metropolitan State University. This program includes coursework relevant to service on a citizen board--not the least of which is Public Ethics and the Common Good.
