We have received and scheduled your request for a bulky item pickup at 679 Hoyt Ave W, St. Paul, Minnesota, 55117 for the following: Other (patio umbrella).

Please place your item(s) out by 6 a.m. for pickup on Friday, 2026-02-13. Please place your bulky item next

to, but not leaning against, your garbage cart. It may be collected as late as 6 p.m.

Additional Information About Bulky Item Pickup:

- All residential households (1-4-unit homes) are allowed 1 bulky item pickup per unit per month included in their garbage service.
- Size guidelines: a bulky item can be up to 1 cubic yard. Examples include a standard stove or a couch.
- If you would like to set out more items than your monthly allotment, you may do so for the cost of \$30 per item. This charge will be automatically applied to your quarterly garbage bill.
- Oversized items *may* be charged as more than 1 item. For example, a large sectional couch with multiple pieces.
- Bulky item collection requests must be received at least 2 business days in advance, and will be scheduled for your next available garbage collection day.
- A separate truck from the usual garbage truck may collect your bulky item, and this may occur at a different time of day. Appliances and electronics are separated from garbage to be recycled.
- Please label items with the word, "Bulky."

A 2026 Collection Calendar is attached, which shows holiday week collection schedules and the on/off week collections for residences with every-other-week garbage collection.

We could not do anything online or easily, and the hard working women working for that company were not empowered to do much. It seems the new structure of administration has also lessened and prevented the number of misunderstandings with billing that resulted in unnecessary assessments.
