NARRATIVE

ICC available for Squad #1574.

On 02-03-2016, at 2048 hours, I, Squad 370 (Dzik) responded to 883 Payne for an Assault call. Comments of the call were that two females assaulted another female. The suspects left in an unknown direction. Both suspects were BF's with black jackets. No weapons were seen.

Upon arrival, I saw that Squad 379 (ofcs. Palkowitsch/Nowicki) was on scene. I entered the bar, and saw officer Palkowitsch speaking to a female (later verbally IDed as: [REDACTED])

I saw that [REDACTED] had fresh blood running from her nose area. I could see that [REDACTED] had several small lumps/abrasions (size of a walnut) near the upper portion of both eye sockets. [REDACTED] was holding a white towel that was wet with large amounts of blood.

I was told that the assault took place in the "males" bathroom.

The labeled photos were TRANSFERRED to the Media Vault.

SPFD Medic 4 (run #3996) arrived on scene. [REDACTED] refused any medical assistance. I heard [REDACTED] tell Medics that she did not lose consciousness during the assault.

I spoke to [REDACTED], and she verbally identified herself too me. [REDACTED] allowed me to take pictures of her injuries. I asked [REDACTED] who the suspects were that assaulted her? [REDACTED] told me that she did not know the suspects. [REDACTED] said that she was assaulted by four females.

I asked [REDACTED] if she could describe any of the suspects? [REDACTED] said no. [REDACTED] told me that she was an "investigator" and she would find out who assaulted her. [REDACTED] told me that she would call police tomorrow with suspect information. [REDACTED] was not cooperative with the investigation. I told [REDACTED] that I was "here to help you." [REDACTED] said something to the effect of: 'I'm a black woman and you are a white cop, we don't call the police.' [REDACTED] said, 'I should not be talking to you.' I gave [REDACTED] my card with the CN.

[REDACTED] told me that she did not want to sign a Medical Release form.

I spoke to the bartender (verbally IDed as: [REDACTED]) who called police, and was working during the assault.

[REDACTED] told me the following: [REDACTED] got into a physical fight with another woman in the men's bathroom. He got in the middle of the fight and broke it up. He was escorting one of the women out, not [REDACTED], along with another woman. [REDACTED] came up from behind, with a chair, and struck the two women with the chair. [REDACTED] ran back into the men's bathroom. The two women ran into the bathroom and assault [REDACTED]. When the suspects left the bar, they told him to call police.

[REDACTED] described the suspects as: two BF's, "their twin's but one is heavier." [REDACTED] said one female's was

wearing light jeans and a black coat. The other suspect was wearing stretch pants and a black coat. Both suspects were about 5'6". One suspect had braids and the other had curly hair.

██████████ said that the suspects and the incident would be on video surveillance from the business's camera system. ██████████ told me that he did not know how to pull up and download a DVD for me. ██████████ said that he could call the manager (TONI, c/p ██████████) in to get a DVD if I needed it. ██████████ told me that investigators could contact TONI if they required the video footage.

At team, I ran ██████████ through the DVS and RMS sites, and could not locate anyone under ██████████ name.
