You continue to state that you had your contractor pulled permit on the furnace, but I still don't see record of having a current permit pulled on file as of today, January 4, 2021. Please note that your appeal of the Vacant Building Registration Notice was denied on December 15 by the Legislative Hearing Officer and you will need to order a code compliance inspection. Once a Code Compliance inspection Report has been issued, permits may be pulled. As of today, no code compliance inspection has been ordered, either.
