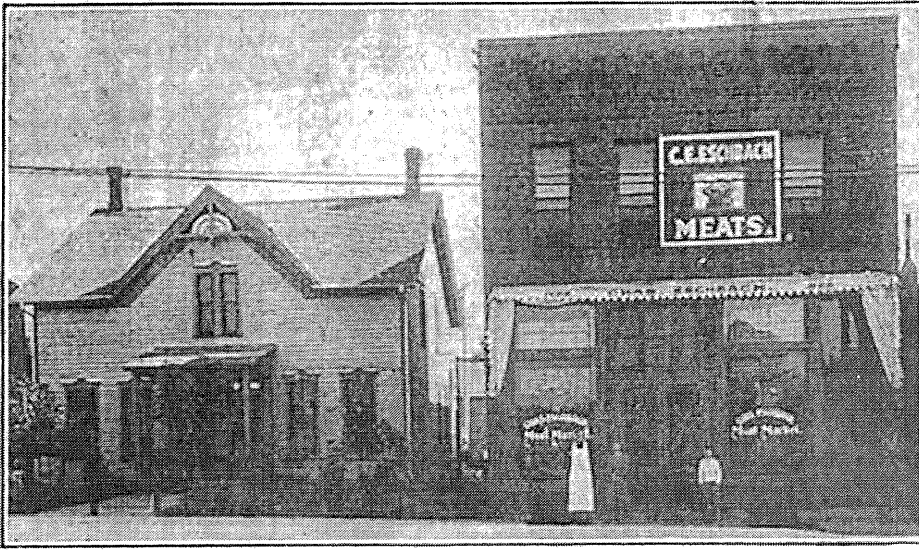
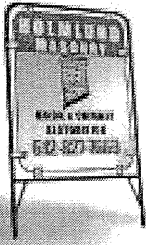

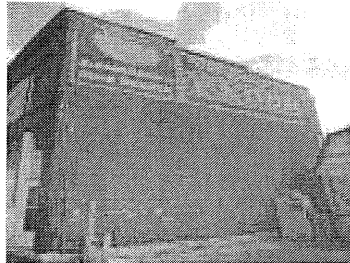

Holmlund Masonry will grind and tuck-point all mortar joints on 2' x 16' area on base of the foundation as indicated in red.



We will remove all material from mortar joints to a depth of not less than 3/4". Tuck-point mortar joints using 1 part mason cement and 3 parts fine mason sand of color as close as possible to the original color. Complete mortar joints with finishing tool and brush. Saturate mortar joints with water before applying mortar. We will thoroughly clean exposed masonry surfaces of excess mortar.



Owners will occupy the facility, which will remain in operation uninterruptively during the entire period of project. Owner will be responsible for keeping doors and windows closed at all times and inside items are properly protected. Any damages as a result of dust and/or debris due to inadequate protection shall be the responsibility of owner.

We will be responsible for cleaning all areas adjacent to our work and leaving the area in a clean condition at the termination of our work, equivalent or better than pre-work conditions.

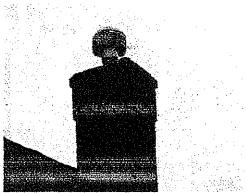
