**Staff Comments**

Hauler records show that garbage service was provided by Republic Services during Quarter 3 2021. Therefore staff recommends approving the assessment. Staff would like to note that the invoice for Quarter 3 2021 included a charge for service from 4/7/2021 - 9/30/2021 (\$114.28.) for a 35-gal EOW cart as well as a credit for the time period in Quarter 1 2021 when there was a service hold in place from 1/4/2021 - 4/7/2021 (\$55.70). These amounts combined lead to a total invoice of \$58.58. With late fees of \$8.79 that total assessment amounts to \$67.37. Hauler records state that there were no additional interactions with the property owner following the request for the service hold on 1/5/2021.
