

Barbara Osthus and Michael Drager at 50 Bates Ave. in Saint Paul are appealing to have our property added to the City of Saint Paul "boulevard-curb" mowing list – the same as 18 and 44 Bates Ave. The City of Saint Paul granted an appeal for the neighboring properties at 18 and 44 Bates on JUNE 5, 2013. On June 1, 2013 at 12:11 AM Michael Drager sent an e-mail to Mia Vang respectively requesting that 50 Bates be included in the appeal. We attended the Legislative hearing on May 31, 2013, but were unable to attend the council meeting as we were out of town.

We thought the appeal was granted for 50 Bates because public works mowed the slope from 2013 to 2016, but quit this year. Due to the past precedents and the mowing of the adjacent neighboring properties, we respectively request that this appeal be granted.

SUMMARY ABATEMENT ORDER

As owner or person(s) responsible for: 50 BATES AVE you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.

1. Cut and remove any overgrown vegetation (including trees) impeding public right of way, sidewalk, blvd, and alley areas. Public sidewalks must be cleared edge- to- edge and up to seven (7) feet in height. Alleys and streets must be cleared from edge- to- edge and up to fourteen (14) feet in height. PLEASE CUT BACK OVERGROWN VEGETATION BACK TO THE PROPERTY LINE FROM STREET (BATES AVENUE). THANK YOU. Comply before July 31, 2017

If you do not correct the nuisance or file an appeal **before July 31, 2017**, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

<u>Charges</u>: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.

You must maintain the premises in a clean condition and provide proper and adequate refuse storage at all times FAILURE TO COMPLY MAY RESULT IN A CRIMINAL CITATION

APPEALS: You may appeal this order and obtain a hearing before the City Council by completing an appeal application with the City Clerk before the appeal deadline noted above or seven (7) days after the date mailed, which ever comes first. The telephone number is (651) 266-8688. You must submit a copy of this Summary Abatement Notice with your appeal application.
