As a thirty-seven-year resident of Saint Paul, I would like to give back and volunteer to assist the city and its residents with the preservation, restoration, and adaptive reuse of the city's outstanding architectural heritage. Such efforts enhance the livability of Saint Paul's neighborhoods and contribute to the city's economic vitality.

What skills/training or experience do you possess for the committee(s) for which you seek appointment?

As a Registered Architect I have specialized almost exclusively in the preservation, restoration, adaptive reuse, and survey of historic buildings and districts for fifty years. My past projects have encompassed a broad array of building types including residences, commercial and governmental structures, ammunition plants, lighthouses, and even claim shanties, variously dating from the late 17th through the mid 20th century; have ranged geographically from North Dakota to Texas and California to Vermont, forty or so states in all; and have featured a variety of building technologies, both archaic and modern, and architectural styles including Georgian, Greek and Gothic Revival, Queen Anne, Arts and Crafts, Prairie School, and strictly utilitarian.

The vast majority of projects have been listed in local, state, and national historic registers with work being governed and guided by the Secretary of the Interior's Standards, State Historic Preservation Offices, and Heritage Preservation Commission [HPC] guidelines. I am well-versed in applying such guidelines and in the committee review process, often having presented projects to HPCs, including Saint Paul's. I believe that my historic and technical experience gained over many years, combined with having to address practical, functional, building code, and construction cost realities, will be of benefit to the Heritage Preservation Commission and to the city and the public it serves.
