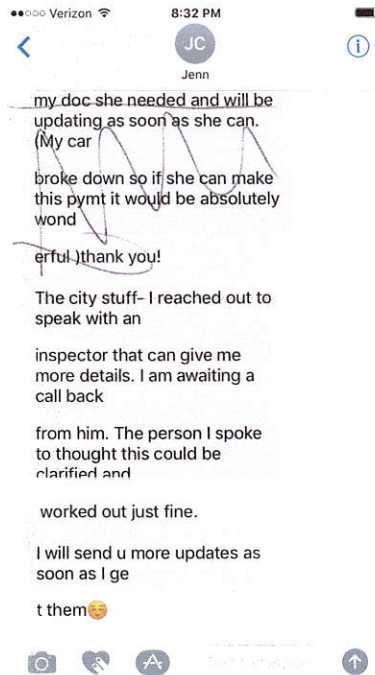
It was them complaining about the weeds down the side of the garage by the fence that did me in, not even the front lawn!!!! So much for land of the tree.

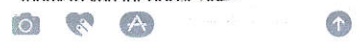
