January 4, 2013 – Email from Larry Zangs – Next Steps to Obtain Approval

- Advised that zoning requirements are met for use of club in the RT1 residential zoning district
- Advised that business needs to be established within 1 year of the former clubs ceasing operation
- Advised that based on the current proposal, as long as we obtain a business license within a year of the American Legion, keep in compliance with the zoning ordinance, we can continue the non-conforming use as an On-Sale Liquor Club.
- Advised that the process can take 75-90 to issue licenses.

January 11, 2013 – Email to Kristina Schweinler:

- Request for recognition of existence – from meeting on 1/3/13
- We requested help to incorporate letter of recognition for liquor license and help to retrieve application for On-Sale liquor license.

January 31, 2013 – Email to Kristina Schweinler:

- We have On – Sale Liquor license application
- Kris requested that we put something “specific” on the paperwork because the On-Sale private club license wasn’t an option.
- We asked how much the filing fees are and where to mail the application.

- Advised that the city was perceived as being discriminative towards our application and business.

July 22, 2013 – Letter from DSI –dated 7/19/13 from Christine Rozek: Deputy Director, DSI

- States: DSI no longer issues licensing and that the MDH/MDA will be responsible for issuing Licensing. Full refunds will be issued.

July 23, 2013 –Letter from Mayor Coleman

- States: As of 7/8/13 MDH/MDA will be responsible for licensing
- Liaison Ombudsman Gary Edwards will act to expedite and eliminate delays and coordination
- City of St. Paul will continue to license and inspect non-food related establishments, such as liquor, entertainment, tobacco, etc.
- Will receive an invoice 60 days prior to expiration date for license you have held in the past.

 1. City doesn't issue liquor licenses to clubs outside the downtown and commercial development districts.
 2. Advised that we will need to become a restaurant if we'd like to have license.
 3. Advised to reclassify and change zoning category.

December 22, 2014 – Email to Larry Zangs –

- Advised that we are recognized as a private club with a limited food licenses and asked him to advise on any additional hurdles to anticipate before the licenses are released.

- Advised us that our time has lapsed – must become a restaurant because we are located outside the downtown area.
- Advised us that we will need zoning approvals before consideration

- Advised us that our other option is to withdraw and request refund
