I would like to comment. I believe the arena should not be sited in the current planned location. There is not adequate parking and transportation to support this facility.

There are no arterial roads to bring attendees in or out of the site. Grand Ave, Cretin Ave, Summit, and Mississippi River boulevard are all two lane roads. There is no transit, except city buses using the roads listed previously. There will be at least 60 Division One Men's and Women's hockey and basketball events. Plus many other special events, meetings, etc. STU will be joining the NCHC Hockey league, whose members include this year's national champion Denver, as well as North Dakota, Minnesota Duluth, St Cloud State, and other top echelon teams. It's reasonable to assume that most games will be at or near capacity. My home is a 5 minute walk to this venue, and on Fairmount there are no weekend parking restrictions.

For many decades, St Thomas was a small men's military primary school. Over the last 30 years or so, and with the benefit of many millions of dollars of donations, it has become the largest private University in the state. Will one of St Paul's iconic neighborhoods be overrun by traffic, parking, and continued development? I hope not.

Dear City Council members –

In connection with the recent appeal of the new St. Thomas basketball and hockey arena and the news related thereto, I am writing to express my strong support for the new facility. My family lives in between St. Thomas' north campus and Mississippi River Blvd., meaning any of the purported detriments of the new arena would directly impact those I care about most. While those purported detriments should be appropriately evaluated, it is also important to recognize the benefits such an arena would bring and to acknowledge the university's history as a responsible and committed neighbor.

I would be remiss if I did not mention that I am a graduate of St. Thomas. The university means a great deal to me, as does the neighborhood that we live in, and the new arena represents a great opportunity enhance the campus – bringing increased economic activity, providing an on-campus venue for students, and creating additional opportunities for youth sports. In the more than 20 years since I attended, the university has continued to grow and evolve. New student living facilities have been added, a new student center replaced a surface lot on Summit and Cretin, and numerous older buildings have been replaced. Throughout all of this change, the university has been respectful of the neighborhood and ensured that any adverse impacts to its neighbors were limited.

Aside from my individual feelings, it is important to call out several important facts. St. Thomas is not asking for a variance from the city to build this arena; it is building in compliance with city rules and within its campus boundaries. The university has also committed to investing in infrastructure that will benefit the neighborhood, including improvements to crossings on Cretin at Grand Avenue and Goodrich. And, a comprehensive environmental review has indicated that the project will actually improve water drainage through investment in drainage infrastructure. As with its prior developments, it is clear that this project has not been undertaken without appropriate analysis and a commitment to benefitting the university and the neighborhood.

Change can be scary. I am respectful of my neighbors' right to request an appeal and to have their concerns heard; however, my experience has been that strong resistance to the project is a minority position amongst my neighbors. As with any proposed changes, people want to make sure things are done the right way. I have no doubt, based on its past history, that St. Thomas is keeping all constituents' interests in mind in pursuing this project.

Dear St. Paul City Council Members,

I am writing to encourage you to support the University of St. Thomas (UST) as it builds a new athletic arena on its St. Paul campus.

I am a long-time St. Paul resident and tax-payer. I currently live at 1523 Pascal Street North, in the Como neighborhood. I lived for ten years at 2218 Dayton Avenue, just northwest of the UST campus, and for 10 years at 1907 Goodrich, just southeast of the campus. I know well what it means to be a St. Thomas neighbor. It is a treat to live within biking and walking distance of a beautiful campus, full of smart, energetic young people, of green space, and of a wide variety of educational, cultural, and athletic events.

I have been a UST employee for more than 25 years, in a variety of staff and faculty roles. I currently direct the Selim Center for Lifelong Learning, a 50-year old St. Thomas community outreach program that provides high-quality educational experiences to help adult learners, primarily older adults, grow in mind, body, and spirit. The Selim Center served more than 400 St. Paul residents over the past two program years.

St. Thomas works very hard to be a responsible citizen. In its efforts to be a good St. Paul citizen, the university is building this new arena on its existing property, working within the frameworks of all existing agreements and regulations. By building on property the university already owns, rather than buying additional land, the tax base of the city is maintained, rather than diminished, a huge issue in a city in which a very large portion of its land mass is non-taxable.

A recent economic development study suggests that UST currently brings just under a half-billion dollars to St. Paul, and almost \$125 million to its surrounding neighborhoods. When UST flourishes, it contributes to the flourishing of the City of St. Paul, a goal I believe we all share.

St. Thomas works hard to be a good neighbor. In addition to the Selim Center, many university events and programs are open to neighbors, either for free or for a deeply discounted price. UST is the only university in Minnesota with a full-time director of neighborhood relations. As is its practice, St. Thomas consulted widely in the process of this project, conducting 17 public meetings.

The university is committed to being a good steward of the environmental resources in its care. This project will bring a number of significant improvements to the campus, improving water drainage, adding a green quad and building a Leed-certified athletic facility.

As both a long-time St. Paul resident and a long-time UST employee, I strongly encourage you to support UST by declining the efforts to stop this project.

Thank you for your work on behalf of our city, and for your consideration of my perspective.

Dear council members Jalali and Jost - I am a long-time resident of Mac-Groveland and strongly support the new UST stadium. UST contributes to the vitality of our neighbourhood as well the City of Saint Paul and the overall metro area. UST contributions are widespread, growing and include economic, educational, entertainment and future high skill employees. This stadium and collegiate Division I sports will add vitality to our neighborhood. Further:

- There are less than 40 events annually or less than one per week, so minimal day-to-day impact on the neighborhood.
- In a metro area with over 3 million residents, the impact of 40 events with 5,500 attendees has a negligible climate impact.
- Many event attendees will walk to games such as students living on or near the campus.
- The stadium is served by the MTC with direct routes on both Grand and Cleveland Avenue. Nearby routes include Marshall Avenue, both light rail lines and the "A-Line". Mass transit will reduce the need for cars and parking.
- UST fans will support existing and potential neighborhood businesses such as Divanis, Gus Gus, Marios, Kims and in the Highland shopping area. Added traffic could lead to re-opened (now shuttered) retail sites at St Clair/Cleveland, Mount Curve/Ford and Highland Village Mall.

My name is Linda Terry and live at 1373 Bayard Avenue and have been a St. Paul resident for the past 22 years.

I am writing to express how much I value the University of St. Thomas. This university is a vital cornerstone in the St. Paul community. I know a recent economic impact report stated the university currently brings 498.8 million to the City of St. Paul. The arena will only increase contributions to the St. Paul community.

It seems to me that those appealing do not understand that the University is building within its campus boundaries and abiding by the existing conditional use permits and that the university is working with the city on all necessary approvals and requirements.

Building the arena on campus is an asset for several reasons. Having an on-campus facility means fans will be able to walk to the games or easily access public transportation--this will reduce traffic congestion that would exist at an off-campus site. St. Thomas is also investing in an infrastructure to improve crossings at Cretin and Grand. They are going to want and need the fans to have a good experience with commuting to the games--no doubt they are committed to figuring this out.

My understanding is that the city of St. Paul was not in favor of St. Thomas building an arena off-campus for tax reasons---so the university appears to be aligning with goals of the city.

I know there are environmental impact concerns. However, the review of the impact on the environment by the city was thorough. The arena is taking down three very inefficient buildings, and a series of surface lots to create the site. The project will actually improve water drainage significantly through investments in drainage infrastructure. In addition, they are adding a green quad to the south campus and building a LEED certified building. These factors demonstrate a commitment to the environment.

None of my neighbors have complained about St. Thomas building an arena. In fact, mostly what I hear is excitement.

When you buy a home near a university, it is a known fact that there will be university activity. In today's world, a university that is actually growing and contributing more to the community is something to be proud of and to support ---it is not something to run from.

I hope you will deny the appeals that have been submitted and allow the university to continue the arena project.
