As you know, this is an uncontested matter concerning the fact that your client obtained signatures from only 33% of the owners of private residences within 300 feet of the premises who were in favor of issuance of a Liquor Outdoor Service Area (Patio) license and the surrounding community was not generally in favor of the license application. This matter has been placed on the public hearing agenda portion of the City Council meeting during which public discussion is allowed. The City Attorney's Office will recommend denial of your client's Liquor Outdoor Service Area (Patio) license.


