#### MEMORANDUM

## **SUBJECT:** Summary of the public process and comments received on the proposal to incorporate bicycle facilities into the scheduled mill and overlay project on Edgerton Street.

This memorandum presents a summary of the public process and comments received on the proposal to incorporate bicycle facilities into Ramsey County's scheduled mill and overlay of Edgerton Street. The full text of all written statements received is attached to the end of this memorandum.

The proposal to implement bicycle facilities on Edgerton Street was released publicly in March 2016. A website was created for the project, providing an overview of the planned improvements, data, project documents, visuals, timeline, and a project contact for questions and comments. Each project website was linked to on stpaul.gov/bikeprojects, a website providing a list of all bicycle projects throughout the city.

Notification was sent to the executive director of the District Council where the project was proposed (District 5), and an offer was extended for city staff to attend a district council meeting to present the proposed improvements.

#### **Edgerton Street Open House:**

A community open house was held for the proposed bicycle facilities on Edgerton Street and was facilitated by city and county staff. Residents and property owners within 200 feet of the proposed project were sent notifications of the open house via mail, along with an overview of the project details and impacts. 560 flyers were sent out for the Edgerton Street open house. The flyers provided a map of the project, a link to the project website, contact information for city and county staff, and information about the project details.

Open House details:

- Edgerton Street Open House Thursday, April 21 from 6:00 to 7:30 PM, Arlington Hills Community Center
- A total of 24 attendees were recorded on the sign-in sheet





#### Written Statements Received:

As of May 13, 2016, city staff received a total of 27 written statements specific to proposed bicycle facilities on Edgerton Street from the following sources:

- Comment forms from the open house (8 statements)
- Comments emailed or forwarded to city staff (4 statements)
- Statements received on Open Saint Paul (15 on-forum statements)

It should be noted that the total number of statements received may include multiple statements from some individuals, as well as some duplicate statements (e.g. an individual may have provided written feedback at an Open House and provided feedback online on Open Saint Paul).

#### **Next Steps:**

The project will be presented to City Council on Wednesday, May 18, 2016. This will be a public hearing. An additional mailing was sent to notify residents and property owners of the City Council public hearing. 560 notifications were sent out. The City Council will consider a resolution recommending that Ramsey County implement the proposed bicycle facilities on Edgerton Street between Maryland Avenue and Wheelock Parkway.

## **Transcribed Open House Statements:**

#### 4. Trevor Roy:

As an occasional biker, the stretch between Maryland Ave and where the bike lane starts is often the most harrowing. Edgerton St. has evolved into a major thoroughfare with vehicles traveling at high rates of speed. While an added bike lane may cause a slight inconvenience when it comes to parking, the added safety benefit as well as the quality of life upgrade the new bike lane would afford is well worth the headache. With the highly popular Gateway trail directly accessible from Edgerton St. it is the city's responsibility to ensure that all who wish to utilize that asset can do so in a safe manner.

#### 5. Steve Lee:

I appreciate the long term/big picture planning that includes bike paths throughout the city!! Considering environmental issues of the future – biking will help reduce our impact on global warming.

The presentation today was excellent. Thank you.

#### 6. Anonymous:

As a county road, Edgerton is an inappropriate "through street" or arterial. It's not built for heavy through traffic, especially semis and trucks. This is a neighborhood RESIDENTIAL street. The speed limit should be 25 mph. This would make it safer for cars, bikes, and pedestrians. Particularly if residents on the west side have to park on the east side and cross, traffic must be slowed.

#### 7. Rex Schultrich:

It seems that Payne Ave would be a better location for the bike lane since the traffic lower. Bike lanes on Payne from Phalen Blvd to Wheelock would improve business access where businesses are. Having Edgerton as a standalone segment creates issues with accessibility that are reduced by putting bike lanes on Payne.

#### 8. Anonymous:




Hello Kathy/Luke,

Hi Luke,

I am a District 5 CPED member and learned of tomorrow's Edgerton meeting at our last meeting. I had a quick question about the upcoming Edgerton St. meeting about new bike lanes along Edgerton from Maryland to Larpenteur.

As you may or may not know, a similar project was attempted and failed back in 2011, except it was for Edgerton south of Maryland, not north. There was a meeting on September 13, 2011 at Wilder Recreation Center with Emily Erickson. One of the most contentious issues in that meeting was the issue of parking loss. The real problem was that **no one adequately studied existing parking patterns** to be able to predict the real effect. The "study" that was performed was just looking at parking for a few days in a single month and was very unscientific.

#### My question is: Have you adequately studied existing parking usage on the affected area of Edgerton?

I'll ask this myself at the meeting if I'm able to make it, but since I'm unsure, I thought I'd email you in advance. :-)

Hello! I have just read the Open House announcement on the plans for Edgerton. I am obliged to park in front of my house on the east side just up from Hyacinth. As the plans stand now, I will still be able to park in front. My life would be considerably disrupted if I couldn't park there. I can't park in the alley, so I would have to compete with the folks who park on Hyacinth. I have lived in the same house for the last 8 years. In my experience, there is little need for a bike lane. You could count on your hand the number of travelers on bike each day. The heavy traffic is cars, trucks, school buses, etc. The road surface is heavily traveled and in very poor shape. The patching is sloppy and left trails of small rocks in my area. It is already an irritation that our alley is not maintained and we pay for snow plowing that is the worst I have ever experienced in St. Paul.

First, the lane would extend to Maryland-Edgerton intersection; one of the most dangerous on the East Side, and force cyclist to either attempt to ride on Maryland to Payne, or route them to Payne via Hawthorne or Orange. I think it is extremely important to stripe bike lanes on Edgerton with this project. These lanes will connect north to Wheelock Parkway, part of the St. Paul Grand Round. Bicycle facilities already exist north of there, and this will be an important puzzle piece in completing the bicycle network.

As you travel south, these lanes will lead people on their bicycles to nearby Payne Avenue, the main commercial street in Payne-Phalen. It is our hope that bicycle lanes will be striped on Payne Avenue, as well, to allow people easy access to businesses in our neighborhood, as well as recreational paths.

## EDGERTON STREET Open House RAMSEY COUNTY

#### What is the Proposal?

Ramsey County is planning to resurface Edgerton Street between Maryland Avenue and Larpenteur Avenue in 2016. The resurfacing project allows us to consider other changes to the road at the same time.

The City of Saint Paul Bicycle Plan recommends bike lanes on Edgerton Street. Adding bike lanes to Edgerton Street during the street resurfacing is being considered. Adding bike lanes will impact on-street parking. The street resurfacing and bike lanes will not result in a cost to property owners.

Ramsey County and the City of Saint Paul are hosting a meeting to share information on the bike lanes and to take public input. The meeting is **Thursday, April 21, from 6:00 PM to 7:30 PM at the Arlington Hills Community Center.** 

#### **Changes to On-Street Parking**

To add bike lanes, some on-street parking would be removed on Edgerton. Between Maryland Avenue and Wheelock Parkway, on-street parking would be removed on one side of the street. This would be similar to the existing design of Edgerton between Wheelock Parkway and Larpenteur Avenue.

#### At the Open House

- The meeting will begin at 6:00 pm. A presentation will begin at 6:15 pm followed by time for questions.
- Preliminary layouts will be shared.
- Ramsey County and City of Saint Paul staff will be at the open house. They will answer questions and address concerns.
- Comment forms will be provided to collect public input on the proposed plan.



An example of bicycle lanes on Western Ave







Bike lanes are already in place on Edgerton Street between Wheelock Parkway and Larpenteur Avenue, and will be reinstalled following the resurfacing.

To accommodate the installation of bike lanes, parking removal is proposed for the west side of Edgerton Street between Maryland Avenue and Wheelock Parkway. Existing parking will be maintained on the east side of Edgerton within the project limits.




