
Dear Legislative Hearing Staff, City Council Members, and all others,

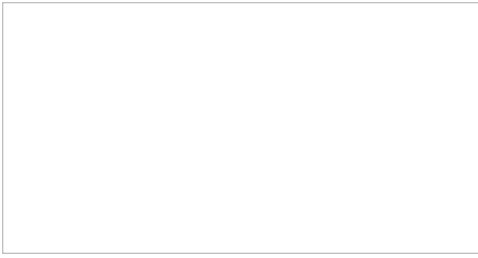

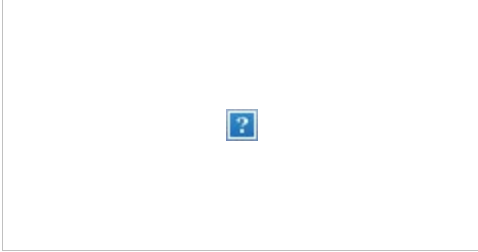
