I am writing on behalf of Love in Action LLC in regards to the fire code matter being discussed at tonight's City Council hearing. We previously requested a continuance to get time to gather bids and did not hear back regarding rescheduling the hearing. It is with regret that due to the miscommunications surrounding the continuance, no one is able to be in attendance at the meeting tonight.

After requesting a copy of the official order today, I received it from Ms. Mai Vang. It appears to be consistent with the equivalency provisions discussed at the hearing with Ms. Moermond. Our electrician thinks he can complete the work as listed from the fire inspector's notes (not the official order) for \$1500. It is our hope that this order can go through as is, however, we are requesting time to review the official order with our Attorney and electrician to confirm.
