AllPhase Companies, Inc. (AllPhase). is pleased to provide a work scope and cost estimate for the cleaning and disposal of a 2,000 gallon UST at 506 Kenny Road, St. Paul, Minnesota.

SCOPE OF WORK

The scope of work we propose to perform at this project consists of the following items:

- The tank purged according prior to cutting the tank.
- The tank will be cleaned according to standard protocol for storage tanks.
- Proper respiratory protection will be utilized by personnel entering the tank for product/sludge removal and tank cleaning procedures.
- AllPhase will purge, cut open, perform confined entry procedures, clean and remove remaining sludge and product.
- Product and or sludge will be recycled/processed according to regulatory guidelines .

A certified tank removal supervisor will oversee the cleaning and removal of the tank

- Contaminated water disposal/recycling at \$4.50/gallon
- DOT approved 55-gallon drums for storage of product at \$70.00/drum
- Hazardous waste will be charged out at cost + 10%

ACCEPTANCE
