249 Erie Street – **This is in regards to removing a Quarter 1 2019 assessment.** Resident was making payments to old Waste Management Account. These payments were transferred to current account.

**Can I still able to abate from 2019 Property taxes?**

There is nothing to Abate from the Taxes. Q1 was - Remove charge per Council Minutes on 10/2/2019 (RLH TA 19-731).
