NOTICE OF PUBLIC HEARING

Sound Level Variance

Church of St. Mark – Grand Old St. Mark’s Festival

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: 1983-1976 Dayton Ave.

Noise Source: Church of Saint Mark has requested a sound level variance, at no specified sound level limit or distance, to present amplified music, carnival rides and entertainment with use of a sound system for their Festival event on Friday, May 17 and Saturday, May 18, 2019 at 1983-1976 Dayton Ave. The variance is requested for the hours of 5:00 p.m. to 10:00 p.m. with a pre-event sound check at 4:30 p.m. on Friday May 17, 2019 and the hours of 11:00 a.m. to 5:00 p.m., with a pre-event sound check at 10:30 a.m. on Saturday May 18, 2019. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 5:00 p.m. to 10:00 p.m. with a pre-event sound check at 4:30 p.m. on Friday May 17, 2019 and the hours of 11:00 a.m. to 5:00 p.m., with a pre-event sound check at 10:30 a.m. on Saturday May 18, 2019. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from the sound sources. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on Friday, May 17 and 5:00 p.m. Saturday May 18, 2019.
