Noise Source: Bad Weather Brewing Company has applied for a sound level variance, at a requested sound level limit of 75 dBA at no specified distance from any stage or sound source, in order to present amplified music, announcements and movies. The event is to be located at the Bad Weather Brewing Company, 414 7th Street West for a Halloween Party for the following dates and times: Friday, October 27, 2017 from 3:00 p.m. to 10:00 p.m., with a pre-event sound check at 2:30 p.m.; Saturday, October 28, 2017 from 11:00 a.m. to 10:00 p.m., with a pre-event sound check at 10:30 a.m.; Sunday, October 29, 2017 from 11:00 a.m. to 10:00 p.m., with a pre-event sound check at 10:30 a.m.; Monday, October 30, 2017 from 3:00 p.m. to 10:00 p.m., with a pre-event sound check at 2:30 p.m.; and Tuesday, October 31, 2017 from 3:00 p.m. to 10:00 p.m., with a pre-event sound check at 2:30 p.m.. The Department of Safety and Inspections recommends the following conditions: 1) The variance will be for the Halloween Party for the following dates and times: Friday, October 27, 2017 from 3:00 p.m. to 10:00 p.m., with a pre-event sound check at 2:30 p.m.; Saturday, October 28, 2017 from 11:00 a.m. to 10:00 p.m., with a pre-event sound check at 10:30 a.m.; Sunday, October 29, 2017 from 11:00 a.m. to 10:00 p.m., with a pre-event sound check at 10:30 a.m.; Monday, October 30, 2017 from 3:00 p.m. to 10:00 p.m., with a pre-event sound check at 2:30 p.m.; and Tuesday, October 31, 2017 from 3:00 p.m. to 10:00 p.m., with a pre-event sound check at 2:30 p.m.. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 75 dBA as measured 50 feet from any stage or sound source. 3) The applicant will provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices must be turned off no later than 10:00 p.m. on each day of the event.

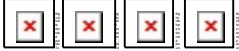
