NOTICE OF PUBLIC HEARING

Sound Level Variance for Podium Sports Marketing In-Line Marathon Shepard Road East of Upper Landing Park to West of Eagle Street

TO: West Seventh/Fort Road Federation, CapitolRiver Council District 17, West Side Community Organization

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: Start at the East End of Upper Landing Park and Finish at Area West of Eagle Street on Shepard Road Noise Source: Podium Sports Marketing In-Line Marathon has applied for a sound level variance in order to present amplified music and announcements at the Start at the East End of Upper Landing Park and Finish at Area West of Eagle Street on Shepard Road. The In-Line Marathon at the Start at the East End of Upper Landing Park and Finish at Area West of Eagle Street on Shepard Road is to be held on Saturday, August 2, 2014, from 7:15 a.m. to 11:30 a.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 7:15 a.m. to 11:30 a.m. for the Event on Saturday, August 2, 2014. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:30 a.m. on the date of the event.
