Thank you for reaching out to the city of Saint Paul about your garbage bill. Our records indicate you had extra bags out on multiple days, which resulted in the charges you see on your invoice. Extra bags are \$4.00 each, plus taxes and fees.

After looking into your concern, the hauler agreed to remove charges for six bags in Quarter 4. I have corrected the Quarter 4 invoice to reflect the new amount. You should see this update on the assessments website within a week. If you already paid the full bill, the overpaid amount is not automatically refunded; it is applied as a credit to the next garbage invoice.
