Good morning Ms. Vang,

Thank you so much.

*Regarding #s 4 and 5, I am not appealing that the extension cord needs to be removed, but that it was written up twice using the National Electric Code for #4 and then the MSFC code for #5, thus resulting in a double loss of points for the same item.

*I have the same concerns for items #1, #3, #8 - all are the same codes but because they were written up 3 different times, it's a significant loss of points. I am hoping to reach a compromise on that as well. I would also like to request additional time to repair/replace the windows in question as winter is not a good time to be pulling out and replacing windows and/or window glass.
