Good afternoon,

Thank you for the application review and for outlining DSI's recommendations. We appreciate the time and consideration given to this application.

We understand DSI's recommendation approval of an Entertainment A License at this time. The applicant is prepared to comply with all conditions associated with the liquor license and take all steps necessary to demonstrate operational compliance.

With respect to the Entertainment B License, we would appreciate further clarification regarding the basis for the recommended denial. The applicant's business model is structured around event rentals and culturally appropriate gatherings, which, by their nature, require entertainment activities and use that exceed scope of an Entertainment A license. From

the applicant's perceptive, approval of only an Entertainment A license may materially limit the ability to operate the business as intended and represented in application.

To ensure alignment with the City expectations, we respectfully ask:

1. Whether the recommendation is based on a threshold issue such as zoning, use classification, occupancy or operational concerns; or
2. Whether DSI would consider approval of an Entertainment B license with conditions, rather than a denial, to address any identified concerns.

If there are specific operational elements, safeguards, or clarifications that would support a favorable recommendation for Entertainment B, the applicant is eager to address those proactively.

We believe a discussion at this stage would be helpful to ensure the licensing outcome accurately reflects the intended use of the space and avoids the need for subsequent amendments or appeals. We would welcome the opportunity to meet and review this further.

Thank you again for your guidance and consideration. We look forward to your direction on the next steps.
