Ms. Haug -

The legislative hearing is not the same as going to Court, so witnesses will not be called, and people are not sworn in. Legislative hearings are recorded, as they are reviewed to prepare meeting minutes, and you are welcome to review that recording if so desired. You will speak with Legislative Hearing Officer, Marcia Moermond, and the supervisor of the inspector who issued the Correction Notice (who will provide a staff report). This is your opportunity to explain why you are appealing the Correction Notice.

Complaints are made to the City of St. Paul anonymously by citizens. The complaints are documented with the City's Complaint Line, and then issued to the proper departments for further review, in this case, the Department of Safety and Inspections, Code Enforcement was notified of the complaint. If any City Code violations are found upon inspection, Orders are issued to correct the issue, and the complainant becomes the City of St. Paul Code Enforcement Inspector.

The hearings take as much time as it takes for the matter to be addressed and a recommendation be made on how address that issue by the Legislative Hearing Officer, sometimes as little as 10 minutes, depending the depth of the issue at hand. All Code Enforcement Correction Notice appeals are scheduled for the same time, and are called to be addressed in order of street name, so how long you will be here depends on your appeal as well as how many others are heard before yours. At this time, no other Code Enforcement Correction Notices are scheduled for appeal on that day.
