I arrived at Regions Hospital and spoke with [redacted] [redacted] [redacted] (6/9/1964, 1447 E 7th St, St. Paul, MN)

When I observed [redacted] she was laying on the bed in the hospital room. I observed [redacted] to have a swollen lower lip and saw blood on her lip and in her lower teeth.

[redacted] told me the following:

[redacted] said at around 1603 hours, her boyfriend, Scott Brian KELLER (6/23/1965, 1072 Pleasant Ave, St. Paul, MN, 651-410-3364) picked her up from her job at, Delta Airlines, (7500 Airport Lane, Fort Snelling, MN). [redacted] said KELLER was driving his work taxi, Airport Taxi #1539 or #1537 (MN LIC: 534KJL, 2004 Ford Freestar, red in color).

[redacted] said her and KELLER had been arguing all week about KELLER wanting to move into her apartment and [redacted] did not want him to move in because her two grandchildren were temporarily living with her. [redacted] said she told KELLER she wanted to break up with him. She said KELLER responded by saying that was fine because he found a new girlfriend. [redacted] said she told him thank God cause she was done with their relationship.

[redacted] said while they were still on Airport property in the taxi shuttle area KELLER grabbed her by her hair. [redacted] said she tried to get out of the taxi to ask for help, but KELLER locked the doors and rolled up the windows so [redacted] could not get out of the vehicle. [redacted] said KELLER used his right elbow and struck her in the face two times. [redacted] said the first time his elbow make contact with the left side of her face near her eye and the second time his elbow struck her in her mouth.

[redacted] said KELLER was holding her back in her seat so she could not get out of the vehicle.

[redacted] said she was sitting on her cell phone as they were driving. [redacted] said KELLER told her to put her phone away. [redacted] said KELLER tried to grab her phone from her when she was trying to call for help.

[redacted] said they drove towards St. Paul and then slowed down at Shepard Rd. and Washington Street to make a turn. [redacted] said when the vehicle slowed down she was able to get out of the van and ran to another female in a vehicle who called 911 and then drove her to the hospital. I attempted to make contact with the female at, [redacted] and received an automated voice mail message. [redacted] did not know the name of the female who assisted her.

[redacted] told me KELLER still had her purse in his possession when she ran from the vehicle (black leather purse, containing her keys, I.D., and other miscellaneous items).

I asked [redacted] the Blue Print Questions:

[redacted] said she has been with KELLER for six months and believes he has been in MN for the past ten years.

[redacted] does not believe KELLER would kill her but would seriously injure her because he hasn't been taking

his medication for his depression.

██████████ said the only other time she was threatened or intimidated by KELLER was on his birthday of this year, June 23, 2013, when KELLER yelled at her at his mom's house and made her never want to go back to his mother's home again. ██████████ said KELLER also lives with his mother at 1072 Pleasant Avenue. ██████████ said their relationship seemed to be getting better up until about the last week when they started arguing often about KELLER moving in with her.

██████████ said today is the day when she most frightened and injured by KELLER and she has never seen him harm an animal.

██████████ gave me KELLER's information but was unsure of his exact date of birth or middle name. ██████████ described KELLER as a white male, about 6'1 to 6'2 weighing about 250 lbs. ██████████ said he was wearing a white and gray horizontally striped short sleeved shirt and blue jean shorts. ██████████ said KELLER has light brown/gray short hair and wears eyeglasses.

I had ██████████ sign a medical release form (form submitted).

I took photographs of ██████████ and gave her a Crime Victim's Information card with the case number.

After speaking with ██████████, I called KELLER's cell phone and asked him if he could meet with me at COOPER'S Grocery Store, 633 7th St. West, to discuss the argument he had with ██████████ and to get her purse from him.

KELLER told me he did not have ██████████ purse because he threw her purse out of the window when ██████████ got out of the vehicle at Shepard Rd. and Washington Street.

Myself and squad 277, Officer's R. Anderson and Z. Tabbott made contact with KELLER in the northwest parking lot of COOPER's grocery.

I told KELLER he was under arrest for Domestic Assault and Interfering with a 911 Emergency Call. KELLER responded by telling me he did not interfere with ██████████ trying to call 911.

I placed KELLER in handcuffs, searched him incident to arrest and placed him in the backseat of my squad car.

On the way to the LEC, I read KELLER the Miranda Warning and asked him if he understood his rights and he said that he did. I asked KELLER if he wanted to tell me what happened to tell me what happened between him and ██████████ (See ICC video).

KELLER told me he went to pick ██████████ up from work at around 1610 hours. KELLER said he got into an argument with ██████████ about a cell phone. I asked KELLER why ██████████ had an injury to the left side of her cheek and a swollen and bloody lip.

KELLER said ██████████ was trying to get out of the vehicle and was protecting her from jumping out of the vehicle. KELLER told me ██████████ may have gotten her injuries as he tried to restrain her. ██████████ also told

me he had sustained scratches to his face and nose and had a bloody nose. I took photographs of KELLER's injuries at the LEC (see photographs).

Squad 268, Officer Yager recovered [REDACTED] purse.

Squad 277 towed the vehicle and had it held for FSVU. Squad 277 returned [REDACTED] purse to her at her apartment.

KELLER has no criminal convictions out of MN.
