## **NOTICE OF PUBLIC HEARING**

Public Works Sewer Utility-Sanitary Tunnel Cleaning Project – Summit Ave. (located on Blvd.)

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

### **Description of Variance:**

**Location:** 2260 Summit Ave. – located on the Blvd.

**Noise Source:** City of St. Paul Public Works Division has applied for a sound level variance at seven sites, including near 2260 Summit Avenue, located on the Boulevard, at a requested sound level limit of 90 decibels (dBA) at no specified distance, for operating general cleaning and containment equipment and other equipment for sanitary tunnel cleaning. Sanitary tunnel cleaning is required. Public Works has indicated the tunnel cleaning work to progress “south to north” with equipment occupying two work sites at a time. It is estimated that each work site will be occupied for four to six weeks. The project proposes to allow elevated sound levels during the time when the sewer tunnel site is cleaned, between the dates of November 4, 2019 to April 30, 2020. Applicant indicates the cleaning would occur from 7:00 a.m. to 7:00 p.m. Monday through Friday, with use of equipment with back up alarms and hand held power tools as well as other equipment. The Department of Safety and Inspections (DSI) is recommending that the occupants of properties located within 400 feet of the work location be notified in writing by St. Paul Public Works a minimum of forty-eight (48) hours prior to the start of the work. DSI also recommends that St. Paul Public Works provide personnel and equipment to ensure compliance with the variance conditions. Contractors working on the project to use best practicable methods for controlling noise, such as, but not limited to noise blankets, shields or portable sound barriers.
