- VII. <u>CANCELLATION</u>. This contract may be canceled by the Purchaser or the State at any time, with or without cause, upon ten (10) days written notice to the other party. In the event of such a cancellation, the State shall be entitled to payment, determined on a pro rata basis, for work or Instruction/Activity/Service satisfactorily performed.
- VIII. <u>ASSIGNMENT</u>. Neither the Purchaser nor the State shall assign or transfer any rights or obligations under this contract without the prior written approval of the other party.
- IX. <u>LIABILITY</u>. Each party agrees that it will be responsible for its own acts and/or omissions in carrying out the terms of this Agreement and the results thereof to the extent authorized by law and shall not be responsible for the acts and/or omissions of the other party and the results thereof.
