Dear Property Representative:

Your building was re-inspected for the Fire Certificate of Occupancy on December 29, 2010. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected immediately. A reinspection will be made on March 4, 2011 at 11:00 AM.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

Bedrooms - Throughout - MSFC1026.1 - Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651)- 266-9090. Refer to the Escape Windows for Residential Occupancies handout for more information.-

Units 1-4 are all double hung windows. Unit A and B are horizontal slider windows.

- 2. Front steps SPLC 34.09 (2), 34.32(2) Repair or replace the damaged handrail in an approved manner. This work may require a permit(s). Call DSI at (651) 266-9090.- Handrail not properly secured.
- 3. Throughout MSFC 703 The fire door must not be obstructed or impaired from its proper operation at any time.-Repair / provide approved door closers on all unit entry doors.
- 4. Unit 3 bedrooms MSFC 1011.2 Remove the materials that cause an exit obstruction. Maintain a clear and unobstructed exitway.-Discontinue storage of clothing and items on the floor. Maintain unobstreted exitways.
- 5. Unit 3 south bedroom SPLC 34.09 (3), 34.32 (3) Repair and maintain the window glass.
- 6. Unit 3 SPLC 34.11, SBC 2902.1, SPLC 34.17, MPC 415.0220 Repair or replace and maintain the plumbing fixture to an operational condition.-Repair or replace and maintain an approved private toilet. Properly secure and caulk the toilet.
- 7. Unit 4 bathroom MSFC 605.6 Provide electrical cover plates to all outlets, switches and junction boxes where missing or damaged.
- 8. Unit 4 south bedroom closet SPLC 34.09 (3), 34.32 (3) Repair and maintain the door in good condition.
- 9. Unit A kitchen closet SPLC 34.09 (3), 34.32 (3) Repair and maintain the door in good condition.
- 10. Unit B bedroom SPLC 34.10 (7), 34.33 (6) Repair and maintain the walls in an approved manner.-Patch the holes and/or cracks in the walls. Paint the wall.
- 11. Unit 1 MSFC 605.4 Discontinue use of all multi-plug adapters.
- 12. Unit 1 MSFC 605.5.3 Immediately, discontinue use of frayed, deteriorated, damaged or spliced electrical cords,-Remove all temporary decorative lighting.
- 13. Unit 3 Kitchen stove SPLC 34.12 (2), 34.35 (1) Repair and maintain all required and supplied equipment in an operative and safe condition.

- 14. Unit 3 SPLC 34.11, SBC 2902.1, SPLC 34.17, MPC 415.0220 Repair or replace and maintain the plumbing fixture to an operational condition.-Repair or replace and maintain an approved kitchen sink. Repair sink hand and caulk sink Repair or replace and maintain an approved private toilet. This work may require a permit(s). Call LIEP at (651) 266-9090.
- 15. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
- 16. SPLC 39.02(c) Complete and sign the provided smoke detector affidavit and return it to this office.
