Chris Samuels, Ramsey County Auditor, gave a report on property tax trends and answered questions from Council members.

Chief Budget Officer Holly Huston reviewed the City Council's 2021 budget process and answered questions from Council members.

Council President Brendmoen stressed that there were many ways to reach Council members by email or phone to participate in the process.

Councilmember Prince asked Ms. Huston asked if there could be a presentation on how the City was meeting the 2020 deficit reduction goals, outside of the 2021 budget process. Council President Brendmoen said she felt that would be helpful in distinguishing the one process from the other. Ms. Huston said she would make a note of that. She said traditionally, the Office of Financial Services prepared a budget amendment closer to the end of the year, and there would be an opportunity to have a meeting just on 2020 and discuss those changes.

Therese Skarda, Assistant City Attorney representing the Department of Safety and Inspections (DSI), gave a staff report on the adverse action relating to violations of three license conditions. This was the first violation within 12 months, and the licensing office was recommending a first-time matrix penalty of \$500. As of today, an inspector was at the business, and it was in compliance.

In opposition:

Licensee Alex Rivero said he'd had this issue ongoing since probably 2018. He'd never had issues and always been in compliance. They didn't mechanic outside, he got along with neighbors and did snow-removal for neighbors, and did lawn-cutting The property was always pristine. DSI records showed there had never been any issues. The only issue was when he submitted a plat map on how the parking spots were supposed to be set up, when he first established the business, probably over ten years ago. He switched those probably ten years prior back and never had an issue, and then when he went in to speak to a certain inspector, and the inspector came out and said they weren't in compliance. Mr. Rivero said he told the inspector he knew, they had been like that forever. So, the inspector said that meant he hadn't been in compliance for years. Mr. Rivero said since then, he'd had nothing but an issue. The inspector had made it more than his job to come out, multiple times on some days, and make his job hard. With customers being there, making rude comments as far as going to saying "If you people would get your things together." The comments were getting almost to the point where they were racist. Mr. Rivero said he had the police come to his location at one point, and physically this guy (the inspector) wouldn't leave the property. At the time of the last violation they were passing put lunches for the neighborhood and had a car blocking so people couldn't just pull in as kids were picking up lunches. At the re-inspection it was the exact same situation. It had been more than just the inspector's job, it was harassment. A different inspector came and she seemed pleasant, but she cited him for the same violations. The Council member said they were going to have someone come and help get the plat map together submitted and approved. Somehow in the conversation it got lost and nobody got back to him, and then COVID took over. He paid an architect over \$1300 to help draw the

maps. The guy came out one time and never came back again, and Mr. Rivero wasn't able to follow up in person because of COVID, and he never got his money back and it never got done. Mr. Rivero said he had never been out of compliance and always asked for help, and it seemed like he had never gotten it. It felt like the more he went down to that office, the more he got doors slammed in his face. He didn't know what to do anymore. He had multiple businesses and was engaged in whatever community he was in, because that was the community that helped the business flourish.

Councilmember Noecker moved to close the public hearing. Yeas - 7 Nays - 0

Councilmember Noecker thanked Mr. Rivero for his testimony, and her colleagues for the layover while she talked to Mr. Rivero and DSI. She said it was clear from Mr. Rivero's testimony that he had always genuinely wanted to be in compliance, and the only reason he wasn't on the subject date was that he was helping the community during COVID, and on other dates due to the lack of assistance that he was asking for, including from her office. She said she took responsibility for dropping the ball on the email forwarded to her in 2018. She noted that Mr. Rivero was in compliance now, and this was his first violation in twelve months. She said she took seriously the concerns raised related to treatment Mr. Rivero said he received from DSI; she said she hadn't corroborated that yet but was bringing it to the attention of the department director to make sure the City was always providing excellent customer service, and not just documenting violations but offering to help. In this case, she wanted to make sure Mr. Rivero got help on what the site plan and striping plan needed to be. She moved to stay the penalty for six months pending no same or similar violations.
