### **CORRECTION NOTICE**

#### Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **October 23, 2017** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup> (see footnote 1, below).

- 1. GARAGES AND ACCESSORY STRUCTURES. All garages and accessory structures must be in sound condition and secure from unauthorized entry. Repair or replace any missing doors, windows, or hardware for same.
- 2. The roof **OF THE GARAGE** is deteriorated, defective, or in a state of disrepair. Repair or replace the roof covering to a sound, tight and water impervious condition. Permit may be required.
- 3. The eaves and soffits **OF THE GARAGE** are in a state of disrepair or deterioration. Repair all defects, holes, breaks, loose or rotting boards, to a professional state of maintenance. Permit may be required.
- 4. The exterior walls and/or trim **OF THE GARAGE** has defective, peeled, flaked, scaled or chalking paint or has unpainted wood surfaces. Scrape and repaint to effect a sound condition in a professional manner.
- 5. The exterior walls **OF THE GARAGE** are defective. Repair all holes, breaks, loose or rotting siding, to a professional state of maintenance.
- 6. The windows and/or storm windows **OF THE GARAGE** are in a state of disrepair. Replace all missing or broken window glass. Make all necessary repairs to frames, sashes, hardware and associated trim in a professional manner. Permit may be required.
- 7. The foundation **OF THE GARAGE** is deteriorated, defective or in a state of disrepair. Repair all foundation defects in a professional manner to a weather-tight, water-tight and rodent-proof condition. Permit may be required.
- 8. STORM DOOR(S): The storm door/screen door **ON THE FRONT ENTRANCE** (s) are in disrepair; repair or replace the door(s).

- 9. DEFECTIVE STAIRS. **STAIRS ON THE FRONT ENTRANCE** are broken, defective, or in disrepair. Repair in a professional manner.
- 10. The roof above the **FRONT ENTRANCE OF THE HOUSE** is deteriorated, defective, or in a state of disrepair. Repair or replace the roof covering to a sound, tight and water impervious condition. Permit may be required.
- 11. The exterior walls **ON THE FRONT END OF THE HOUSE** has defective, dirty surfaces. Repaint to effect a sound condition in a professional manner.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after **November 23, 2017**, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges**<sup>2</sup> and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)

As owner or person(s) responsible for: 1560 ARLINGTON AVE E you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.

- 1. Remove improperly stored or accumulated refuse including: garbage, rubbish, loose and scattered litter, discarded furniture, appliances, vehicle parts, scrap wood and metal, recycling materials, household items, building materials or rubble, tires, brush, etc., from yard areas INCLUDING BRANCHES/TREE PARTS/BRUSH PILE, BROKEN GLASS, BAGS OF YARD WASTE, CLOTHING, TOWELS, INDOOR CHAIRS, SINK, TABLES, METAL RACKS, LITTER, LOOSE TRASH, PLYWOOD, SCRAP METAL, PLASTIC BAGS, PLASTIC CONTAINERS, DRAWERS, SCRAP WOOD AND MICROWAVE ON REAR DECK, FRONT STAIRS AND AROUND GARAGE. Comply before October 30, 2017
- 2. Cut and remove tall grass, weeds and rank plant growth from REAR yard. Comply before October 30, 2017

If you do not correct the nuisance or file an appeal **before October 30, 2017**, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

<u>Charges</u>: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.
