Summary Abatement Appeal:

We are appealing the Summary Abatement re. our patio over the garage. The items on the patio are all used for outdoor living and gardening. Items include: Pots and planters, a wheelbarrow for gardening, a small woodshed to house firewood, firewood, patio furniture (table, chairs, bench, and umbrella). None of these items are “improperly stored or accumulated refuse.” Our patio garden utilizes eco-friendly planters made of 5-gallon buckets and garden-specific plastic netting. We also utilize a homemade wooden tiered box to prevent pests from digging up our plants. The planters are used in the spring and summer and currently do not house plants due to the season. We do plan to use our garden this upcoming spring and summer.
