Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting scheduled on **Wednesday, December 7, 2016 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.

Enclosed are copies of the resolution and supporting documents which will be presented to City Council for their consideration. This is an uncontested matter concerning the fact that a Saint Paul Police Officer, posing as a patron, was allowed to leave the licensed premises with an alcoholic beverage during a compliance check on September 15, 2016 (CN #16-188-411) in violation of Saint Paul Legislative Code § 409.08 (15).

Per Saint Paul Legislative Code § 409.26(b) (9), the licensing office will recommend a \$500.00 matrix penalty. In addition, they recommend three (3) new license conditions be placed on the license.


