Subject: Concern about Organized Trash Collection Rates & Rules

Dear Mr. Tolbert:

I am a resident of Ward 3 and would like to relate my concerns with the effort towards organized trash collection. Overall, I think it is a good idea for the City; however, there are some areas I ask that you address.

We own (and live in) our Highland duplex, renting out the other side. We have the smallest trash bin from our hauler and, together with our tenant, do not even fill this bin one-fourth of the way full each week. Our trash disposal costs \$75 per quarter (\$25 per month) for BOTH addresses. This is because we (and our tenant) are environmentally conscious. We recycle, we compost, and we make purchasing decisions with the earth in mind. We do NOT dispose of "bulkies" -- not in the six years we've lived here. We are concerned about the possible elimination of the option to share garbage disposal that is currently allowed by city ordinance. Not only would the proposed rates, when added to the "annual administrative fee," be a HUGE increase over what we pay now, but if the sharing option is eliminated our costs will almost TRIPLE.

We find this cost increase unacceptable, especially considering the property tax increases we are facing at the same time. It feels as though we are being punished for being environmentally sensitive and we object to subsidizing, through our garbage rates, people who live a throwaway lifestyle.

We beg the city to require that residents pay to dispose of their OWN "bulkies," and allow sharing of garbage services. If illegal dumping is a problem in the City, the City should find another way to address it other than requiring property owners to pay for the disposal of other people's garbage.

We are actually almost ready to leave Highland Park over this and other issues with City services (or lack thereof,) and taxation. Which is too bad, because I believe we are the kind of people that you wish to keep in Ward 3.

Chris,

I am writing to let you know that I am totally against this whole process of the City of St Paul's involvement in the trash hauling process. While there are certain areas such as education or transportation where it makes sense for the government to provide services, trash hauling is not such an area.

My points are:

- I do not have 15 haulers in my alley... maybe 5 and that is because the large corporations came in about 20 years ago and "bought" their way in to the market by offering low priced hauling. This is how a free market works. The large companies are now no cheaper than the other providers.
- I chose to stay with my local small provider then because they provided good service and I wanted to support the local, family- owned business. Frankly, it is in these small businesses that model good citizenship and expect it of their employees (both at work and outside of work)..... the large bureaucratic operations (including the City) often do much less to model good citizenship.
- At times, I have shared service with an elderly neighbor because neither one of us produced much trash..... this is not an option in the new proposed system.
- The free market makes these haulers have to compete and attract customers, a regulated system does not do this..... and prices will rise.
- I have no interest in paying the city an "administrative" fee of \$52/ year related to trash hauling..... for what I am not sure. Plus, why need an "administrative" fee if you are still having private businesses provide the services. Many of us have existing containers, either self-purchased or provided by the hauler, so why not utilize those?
- In a free market, which is what the US is supposed to espouse, the City has no business forcing businesses to pay a specified wage or otherwise define their business model. The marketplace will force the most efficient, cost effective solutions.
- The excuse that this is to help take care of bad actors who dump trash ,etc. is lame. We should be teaching citizens responsibility not by covering for their bad acts and having the rest of us pay for it. I just returned from a quick trip to Canada.... I was surprised to see the cleanliness and a wide variety of well-behaved citizens, i.e. , following the speed limit, not dumping trash out the window or on the street, etc. This was not because I saw lots of "policing" entities. Let's work on our attitudes and responsibility instead of using the government to cover for bad behavior.
- Over a year of the city's staff and the business's staff has been consumed by this ill-advised effort. What if those dollars had been put to more productive use to teach people the behaviors associated with responsible citizenship?

A lot of time and money has been wasted by all parties working on an issue that is not a "problem" that needs to be solved by government. Let's put a stop to this inefficient and ineffective effort to meddle in business's private operations in a competitive marketplace.

Council Member Tolbert,

It was good to see you Wednesday night. It's hard to comprehend that it has been almost a year since the council met to start the process to organize trash collection in St. Paul. I wanted to weigh in on the coordinated collection agreement. As you know, I have been against Organized Collection from the beginning, I made that clear in our meetings. I also think that the time for that conversation ended on July 21, 2016 when the council passed the resolution to begin the OC process.

The last 10 months of negotiations have been grueling. Despite what the Waste Management attorney said about city staff, I feel the process was well managed. There were more than a few times when I would have liked to throw Kris and Ann out the window, but I know there were times they felt the same about me. That's how negotiating goes. The agreement represents multiple compromises on both sides, and was signed by all fifteen haulers. I believe it is a solid program that will serve the vast majority of St. Paul residents well.

The issue of rates was brought up with a comparison to Maplewood. Maplewood was taken away from the independents on a low ball bid by a national company (the lowest rate in the state). The same

company has the contract for North St. Paul and charges 76% HIGHER for their 35 gallon cart than they do in Maplewood. For a real comparison, North St. Paul has bulkie collection included in their program. Their 35 gallon cart rate with taxes and bulkies is \$22.48 for 2017. Our proposal is actually for a 2019 rate so adjust NSP by 2.5% a year for CPI and their 2019 rate would be \$23.62. Our hauler proposal for a 35 gallon cart is \$23.77. For \$.15/month we are going to carrying bad debt for up to a year, provide walk up service to handicapped residents, take Holiday Trees for free, provide a free cart size change every year, and do the billing. Keep in mind NSP doesn't have a Frog Town or a North End or a Payne/Phalen area like St. Paul and its mostly street pick up which is conducive to fully automated collection. The city spent \$300K on consultants who know the industry and the market. I must assume they approve of the agreement.

I hope the council approves the resolution so that we can begin the ominous task of implementing the program.

Dear Council Members,

I have greatly appreciated your vote to authorize the process of organizing trash hauling in St Paul and I am incredibly grateful to City staff for their efforts on our behalf to make that happen. I would like to express my thoughts regarding the proposed agreement for organized trash collection in St Paul. I served as a member of the Macalester Groveland Community Council for six years. During that time I met with many of you or your representatives to address the Community Councils effort to study the current system and propose another possibility. I also facilitated the community conversations held by the Community Council which included conversations with hundreds of people as well as two meetings with the haulers. And I interviewed representatives of other cities who have organized systems. I was part of a team of volunteers who poured through our survey data and had input on the writing the final report. So many of my thoughts are based on those findings.

I am strongly in favor of organized trash collection and the proposed plan accomplishes many of the things that I believe will lead to a successful change to the current system.

It includes the removal of several bulky items each year from residences which hopefully will lead to less illegal dumping. It sets up a good system to handle customer service and billing throughout the City. There should be greatly reduced truck traffic - meaning less air pollution, less use of fossil fuels and less wear and tear on City streets and alleys. Rates will be uniform throughout the City taking away the need to bargain for the best rate from various haulers, which I heard often from fellow citizens was confusing and time consuming. And the wage standards are admirable as well, allowing workers a good wage for difficult work.

One of the things I heard most often from my fellow residents is not truly addressed in the new proposal and that is differential pricing that rewards those who recycle, compost and just simply reduce waste. A difference of \$7.15 per month between a 32 gallon container and one three times its' size does not encourage residents to reduce and recycle more. Those who have shared service in the past will no longer have that option. The option of bi-weekly service is available for only \$10 less a month than a behemoth cart of 95 gallons! I hate to say it, but that is truly disappointing and almost laughable. I understand that the haulers have no incentive to induce customers to reduce, but I truly believed the City saw that as a priority. As I listened to those who spoke against the proposed plan at Wednesday's City Council meeting, I heard many speak of exactly this issue. For those who have been responsible; taken the time to recycle, compost and shop differently, those who have worked hard to reduce and/or live on a fixed budget these are not the prices they were hoping for. It appears to penalize them instead of reward them for their efforts.

I still strongly support an organized system. If this is indeed the seventh and final offer from the haulers, I hope that something will be built in to sharply reduce the rate of the smaller and bi-weekly service containers each year throughout the contract. I appreciate your willingness to read and consider my thoughts.

I am glad you decided to wait another week to vote on this. I initially had little positive comments regarding the proposal before the full details come out recently, but after seeing the costs associated with it - I am absolutely against it.

My rates would more than double. I pay just under \$14/mo for the smallest bin (35 gal) and I have 1-2 bags each week. It's always 2 bags when I pick up trash along our alley and around our block, and our family does that every so often.

Who is getting the savings? If people want to save - they can shop around.

We moved here 2-1/2 yrs ago and that is exactly what I did.

We have never had the need for disposing of large items, and do not intend to. That is almost encouraging people to throw away more items. We take our compost multiple times a week and the brush/leaves that we pick up out of the street when we clean the drains (through the adopt-a-drain program) on our street in the Payne-Phalen area.

I think many residents do more than their share for the city as it stands and does not need the City for this 'improvement'.

Reducing the wear and tear on the alleys is a legitimate savings, but has it been passed down in the cost? Were reductions on the current road maintenance costs also made?

I also do not understand the high (\$52) yearly admin cost. A breakdown of that would be helpful, but still unlikely to change my mind. Even without that yearly cost - my rates would go up 175%.

Dear Council Members,

I support the Organized Trash Collection initiative. Organized trash collection is more efficient, more environmentally sustainable, and more equitable for all residents. As currently planned this plan would save me \$5.80 a month (\$69.95) a year, while adding the benefit of disposing of bulk items.

Our existing open system is touted to be a free market solution, but truly free markets allow both buyers and sellers to understand what they are getting and for what price. Under the open system Saint Paul haulers had an unfair advantage over the public since residents faced opaque pricing, high switching costs, and stealthy price increases. Residents who wished to take advantage of the market by comparing prices and services had to make numerous phone calls to collect and compare various apples-to-oranges terms and prices, all to save perhaps \$10 a month. Some people may feel that was worth it, but it's definitely not worth my time, and is totally unfair to the many residents without the time, skills, and ability to negotiate for a low-cost commodity service. In effect the people with the least time and money were subsidizing trash collection for penny-pinchers.

I do wish the plan addressed yard waste pickup. I was separately paying \$102 a year for weekly yard waste pickup, and it will be inconvenient to separately contract that service, if I can still do so economically. Also, while I understand Saint Paul's desire to support smaller haulers and am OK paying a bit more to keep the local haulers in business, I believe that we could save residents even more money by putting the whole process out to bid. The solution the city has developed is probably the best one overall, but if residents continue to express concerns about price, a citywide bid should be considered.

The 5 and 7 year contract proposed numbers leave a lot to be desired in terms of realistic assumptions, calculations, and objectives. Saving an estimated \$35 a year is not a significant enough savings to embark on this labor intensive effort of meetings and discussions and scenarios with trash haulers. And \$1.99 for bulky items?? That is not a realistic number for one year let alone 5 or 7. Billing for \$1.99? Again, not realistic. Yard waste "subscription" fee? What is that and is this optional? How exactly will all these numbers be tracked and measured over time? Who is doing that? The city? That means my taxes are being spent on this and I can think of many other uses for my tax dollars.

Newspaper articles indicate the city has demanded very thin profit margins from the trash haulers - if this is true, the effect will be to drive many of them out of business - is that an objective? What is the city going to do to ensure ALL the current existing trash haulers stay in business at current levels? Where and how will that be tracked and measured? Also an account of a \$52 annual assessed fee on every homeowner/ address does not seem to be represented in the 5 and 7 year proposed numbers. Where are all the TRUE costs?

My husband and I were not able to attend the public hearing regarding Coordinated Garbage Collection. However, we would like to express our opinion regarding the proposed resolution – **we are NOT in favor of this proposal as it stands.**

We currently share garbage service with our neighbor. We enjoy excellent service at a competitive cost - \$21 total cost (\$10.50 per household) for a 65-gallon container – that we were able to negotiate in the current open market system.

Here are some of the concerns we have with the current resolution:

- The cost of the new Coordinated Collection service is far more expensive!

- Why would we pay additionally for Christmas tree removal, when we can already drop our tree off at the local compost site for free?
- Why do we need to pay an extra \$52 on our property taxes when the garbage companies are handling the monthly billing?
- What are you planning to do with all the existing garbage bins? I certainly hope they will not go to waste.
- If you are trying to tackle the issue of large garbage items left randomly around the city, the solution needs to be affordable, convenient and easy for people. This resolution does none of that.

Instead of limiting the service to pick-up of only three items per year, why couldn't the city offer a Spring Clean-up Day every year – where items can be left on the boulevard and the garbage haulers (or the city) come and pick it up (for free). We have lived in other cities that offered that opportunity – it garnered great participation and cleaned up the city beautifully.

I'm guessing the problem areas experiencing garbage dumping may be low-income regions? Do you really think these individuals are going to pay their garbage bill on time, if at all? Do they even own property? How is adding this "service" to property owners going to solve the issue of the garbage dumpers, who likely don't even have any skin in the game?

In addition, we view this type of mandatory citywide resolution as a regressive tax that is not equitable across income brackets. I love St. Paul and have lived here most of my life. Unfortunately, it's getting too expensive to live here – and even more so if this resolution is passed.

Please do not pass this resolution, thereby eliminating our freedom of personal choice and free market competition – which yields good service and competitive pricing. This after all, is the bedrock America was founded upon.

Dear Council Member Bostrom and Staff,

I attended the meeting on Wednesday and **appreciated your statement asking to delay the vote on organized collection. I attended to show my presence in opposition, which I'll cite for several reasons.** My hope in writing this letter is that you'll continue to listen to residents of St. Paul and what their concerns are, and **consider abandoning or changing significantly this plan for organized collection.**

Firstly, in past conversations calling Council Member Thao's office (my ward, as I live in Lex Ham), I've been told my aides that organized collection "is a done deal. It's not IF it's passing, it's WHEN". That concerns me because **public input was not even given until last Wednesday, when apparently the council was set to vote. Is that how issues that**

will increase our taxes and affect our choice get decided, when the council has already agreed about their stance on the issue? Again, I appreciate your willingness to think this matter through with more time.

Secondly, I express my "if it's not broke, don't fix it" sentiment expressed by others who spoke on Wednesday. **This is NOT an issue that has been expressed strongly by members of my block or immediate neighborhood.** We enjoy our current haulers, the right to choose, and to change business if our needs aren't being met. I'm concerned about what residents will be able to do if service in the new contract is not being carried out satisfactorily, and what incentive haulers will have to do good business, as they have proven they are able to do so well under the current system. What will we do, call the city? The current recycling program has proven that it is not easy to get a response, or see changes this way. **Under the proposed new system, I along with several of my neighbors will experience an increase in fees, and we do not produce much trash. This is disheartening when there is not an incentive for folks to produce less trash, while having to pay more.** If this issue is being categorized as an "environmental one", then let's be clear that it's not one-sided. Please consider allowing limiting haulers to certain days of the week in certain neighborhoods to limit traffic, while allowing residents the chance to still choose their hauler.

Thirdly, I'm disappointed by the way in which citizens and have been allowed to engage in this process from the start. I spoke with my hauler, who said that they've been unable to discuss the contract or details during meetings, as the council has not allowed for that. To me it appears as if the council is set on making organized collection happen, without asking those involved for their input. Wouldn't you want to have haulers on your side, hammering out important details that they have pertinent information on?

Finally, related to my point above about engaging residents, I have a family member who does not speak English and who requested to have a document translated of meeting minutes to stay abreast of this issue--she followed the prompt on the bottom of the page to request a translated document. Not only was she answered by someone who wasn't able to help her, but finally when an interpreter was placed on the line and she communicated her wish for a translated document, we never received it--that was 3 months ago. I'm concerned that while the Mac Groveland Neighborhood Council framed organized collection as something that will serve marginalized and immigrant families better, clearly non-English speaking residents aren't even able to stay abreast of the issue because there are not accommodations to do so. Imagine those residents who don't even know this issue is being discussed, because there are not interpreters and employees to reach out to them. With my current hauler, we are able to speak personally with a Spanish-speaking staff member to get our needs met, with no barriers. This is a great example of when businesses know their customers, there isn't a need for government involvement unnecessarily.

One of the reasons I love St. Paul is its vibrant diversity and value on small business, as well as its attempt to invite democratic processes on important issues. Unfortunately in my experience, organized collection has not been one that reflects these things. Again, I urge you to vote to abandon the current plan for organized collection at next week's meeting when you vote.

Dear Councilmember Tolbert,

I am writing to ask you to support consolidated trash collection for the City. At the public hearing last week, we heard comments both for and against consolidated collection. The majority of the comments against consolidated collection pertained to increased collection costs for individual households. I can relate to this sentiment, as a low volume generator in a "desirable" neighborhood to service, I will also see a cost increase. However, I recognize that not everyone pays such low rates. And I believe we need to make the pricing more equitable across the city.

While I understand the concern with increased individual costs, it should be noted that a main reason the City is not seeing lower costs is because we chose to retain all 15 licensed haulers rather than putting out for RFP and selecting one or a few to service the city. City staff listened to the priorities of the Council (informed by public input) and worked hard to include small businesses. We can't have it both ways - since we must achieve more equitable pricing throughout the city, if we choose to do that using 15 haulers, we will pay more. If we opt to reduce the number of haulers, we'd likely end up with lower prices. We as a community must decide what is more important - preservation of small businesses or individual cost savings.

I also heard plenty of concern regarding discouraging waste reduction, recycling, and composting since the proposal does not provide significant price breaks between service levels and also does not allow residents to share a cart. I share this concern and would like to see this addressed if possible, possibly by increasing the cost for the larger carts and decreasing the cost for the smaller carts. However, I do not think we should give up on consolidated collection if this cannot be worked out immediately. Now is the time to consolidate collection - this is a great first step to incentivizing sustainable behavior change and we should take it now. We'd be reducing illegal dumping, providing lower costs on average, improving local air quality, and minimizing wear and tear on the roads. I urge you to vote to approve moving forward with contract negotiations.

I read the article about the proposal for city-wide trash collection in the Pioneer Press on Thursday July 20, 2017. I've been waiting to see what the City was planning to charge, because I believe my monthly costs are already reasonable. I've had the same trash hauler since I bought this house in 1985. Several years ago the neighborhood solicited requests for proposals from trash haulers in an effort to get better pricing so we only have 3 different trucks that travel the alley. The recycle truck makes two passes each Monday simply to pick up both sides of the alley with their automatic arm, so I don't really feel that "minimizing alley traffic" was a priority when the City took over the recycle program.

Presently I pay \$5.00 per week; I'm allowed two (2) 30 yd. bags per week. My use of trash bags have decreased because I probably recycle 70% so I have no need for larger trash containers. I also don't want or need "large items" picked up so why should I pay for such? If folks need that service I believe they should pay for that for their own address, but it should not be city-wide. I don't believe all residents should all be charged to subsidize a few.

My present rate: \$5.00/week x 52 weeks = \$260.00 per year; that costs includes waste management tax and Ramsey County environmental charge.

At the proposed rate of \$21-\$32 per month x 12 months = \$252 to \$384/year PLUS \$52 yearly administrative costs = \$304 to \$436 per year! That's still significantly more than I am presently paying.

Does that proposed monthly costs include all the taxes or is that additional?

I plan to retire soon, and will not have an outside income. I certainly cannot afford to pay any increases due to the City's involvement. Right now if I do not like the trash hauler's costs I simply call another one, and I'm a firm believer that competition is good and keeps costs fair. Fixed pricing by the City doesn't offer residents any price comparison or options to shop for better pricing. And as I understand it residents are not allowed to opt out. So much for choice.

You know Chris, after living in St. Paul for 43 years I wish I had more faith that the City can manage my household expenses better than I can, but with all the services that the City is already handling, some less than satisfactory, I don't understand why they thought they should tackle this issue. I didn't think it was broken, but I do understand certain areas of town have a problem. That could be due to the rate of rentals, due to the demographics and that fact that irresponsible folks don't care about laws. Littering still occurs and illegal dumping will too. City-wide trash hauling will not be the fix.

Please consider the amount of seniors in your area; most of us are, or will be on a fixed income. My property taxes continue to rise (add street assessments), along with sewer assessment and I can see eventually I will not be able to afford to live in St. Paul. That's a sad state of affairs when seniors can't afford to keep their homes they worked so hard to pay off the mortgage.
