## **NOTICE OF PUBLIC HEARING**

### Podium Sports Minnesota Half Marathon 2015 SLV Upper Landing Park Start and Shepard Road/Sherman Finish

TO: West Seventh/Fort Road Federation and CapitolRiver Council District 17

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

#### **Description of Variance:**

**Location:** Start at the East End of Upper Landing Park and Finish at Shepard Road and Sherman

**Noise Source:** Podium Sports Marketing Minnesota Half Marathon has applied for a sound level variance in order to present amplified music and announcements at the Start at the East End of Upper Landing Park and Finish at Shepard Road and Sherman. The MN Half Marathon at the Start at the East End of Upper Landing Park and Finish at Shepard Road and Sherman is to be held on Saturday, August 1, 2015, from 6:45 a.m. to 12:00 p.m., with a pre-event sound check from 6:45 a.m. until 7:00 a.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 6:45 a.m. to 12:00 p.m., with a pre-event sound check from 6:45 a.m. until 7:00 a.m. for the Event on Saturday, August 1, 2015. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:00 p.m. on the date of the event.
