Location: Parking Lot of 1990 Suburban Avenue

Noise Source: La Shandra Exom has requested a sound level variance, at a requested sound level limit of 85 dBA at 50 feet, to provide the use of a sound system for live music in the parking lot at 1990 Suburban Avenue for Jam Fest. The variance is requested for the hours of 12:00 p.m. to 10:00 p.m., with a pre-event sound check at 11:00 a.m., on Tuesday, July 4, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 12:00 p.m. to 9:00 p.m., with a pre-event sound check at 11:00 a.m., for Jam Fest on Tuesday, July 4, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. The applicant may need to provide a barrier, to act as a sound absorber, to contain excess sound from leaving the area 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:00 p.m. on the date of the event.

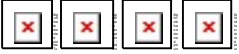
