

## **JOINT POWERS AGREEMENT**

**THIS JOINT POWERS AGREEMENT** is between the City of St. Anthony Village (hereinafter referred to as "St. Anthony Village") and the City of Saint Paul, Minnesota (hereinafter referred to as "Saint Paul"), both political subdivisions within the State of Minnesota, which are empowered to enter into joint powers agreements pursuant to Minn. Stat. § 471.59, subd. 10.

**WHEREAS**, Saint Paul and St. Anthony Village wish to detail the terms of use of the Saint Paul Fire Department's training facility at 1683 Energy Park Drive, Saint Paul, Minnesota by St. Anthony Village.

**WHEREAS**, the parties have hereinafter set forth the terms of said use by St. Anthony Village.

**NOW, THEREFORE**, it is hereby agreed by and between the parties as follows:

1. By prior arrangement with Saint Paul Fire Chief, St. Anthony Village may use the Saint Paul Fire Department training facilities located at 1683 Energy Park Drive, Saint Paul, Minnesota for firefighter training purposes.
2. Saint Paul will make such training structures and devices at the facilities available to St. Anthony Village during evening and weekend hours, on the dates requested by St. Anthony Village, subject to the Saint Paul Fire Department's own prior commitments.
3. St. Anthony Village will pay St Paul as set forth in the fee schedule attached as Appendix A, and incorporated herein by reference.

Sessions will be determined by mutual agreement between the parties and approved by the Saint Paul Fire Department as to the precise dates and times. If a training session is canceled less than ten (10) days prior to the session's scheduled time, a cancellation fee of one hundred fifty dollars (\$150) will be paid to Saint Paul.

4. Facilities designated for St. Anthony Village use shall be the Drill Tower, the Burn Simulation Building, the Haz/Mat Training Pads, the Pump Test Pits, Training Props, and a Classroom.
5. St. Anthony Village agrees to defend, indemnify and hold harmless Saint Paul and the Saint Paul Fire Department from any claims made against them resulting from the use of the training facilities by St. Anthony Village as described in this agreement, except for any claims resulting from negligence on the part of Saint Paul or the Saint Paul Fire Department. St. Anthony Village will pay Saint Paul's reasonable attorney's fees, costs, and disbursements incurred as a result of any claims brought from said use, except for any claims resulting from negligence on the part of Saint Paul or the St. Paul Fire Department. Nothing in this Agreement

shall constitute a waiver of the statutory limits on liability set forth in Minnesota Statutes Chapter 466 or a waiver of any available immunities or defenses.

6. This Agreement shall commence on September 15, 2016 and shall expire on September 30, 2017 ("Expiration Date"). Notwithstanding the foregoing, either party shall have the right to cancel the Agreement before the Expiration Date by giving the other party written notice of such cancellation at least sixty (60) days prior to the date of such cancellation.
  
7. Any notice to be given by either party upon the other under this Agreement shall be properly given: a) if delivered personally to the Saint Paul Fire Chief if such notice is to be given to Saint Paul, or if delivered personally to the St. Anthony Village Fire Chief if such notice is to be given to the St. Anthony Village, b) if mailed to the other party by United States registered or certified mail, return receipt requested, postage prepaid, addressed in the manner set forth below, or c) if given to a nationally, recognized, reputable overnight courier for overnight delivery to the other party addressed as follows:

Notices shall be deemed effective on the date of receipt if given personally, on the date of deposit in the U.S. mails if mailed, or on the date of delivery to an overnight courier if so delivered; provided, however, if notice is given by deposit in the U.S. mails or delivery to an overnight courier, the time for response to any notice by the other party shall commence to run one business day after the date of mailing or delivery to the courier. Any party may change its address for the service of notice by giving written notice of such change to the other party, in any manner specified above, 10 days prior to the effective date of such change.

8. St. Anthony Village will be responsible for any and all required cleanup required as a result of this usage. St. Anthony Village will clean the training facilities to the satisfaction of Saint Paul Fire including the removal of all debris.

## Appendix A

Facility fees are for a **4-hour minimum** with an additional hourly rate for additional time. Rates are subject to change or review annually.

Three classrooms are available with projectors, screens, white boards, audio, and computers set up in the rooms. Classroom space is included with other facility rental at **no additional charge**, but you must **request the additional classroom space** on your application for scheduling purposes. See below.
