The Saint Paul HREEO Commission seeks candidates with strong community involvement experience. Briefly describe your background that relates to the purpose and work of the Human Rights Commission. As a Saint Paul resident, I have been involved with local policy-making. I've helped organize a grassroots organization to advocate for the recently adopted Earned Sick and Safe Time (ESST) ordinance in the City of Saint Paul. The purpose of this ordinance will benefit all workers in the City, but more importantly will help the most marginalized groups. Single mothers from communities of color, disproportionately have more than one low-wage job that does not offer earned benefits such as paid-time-off to take care of their child when they are sick, and often have to choose whether to take care of their child or keep their job. Without ESST the cycle of women staying in abusive relationships and continuing the cycle of poverty through low-wage jobs. Through studying and advocating for equitable public policies, I believe I am a good fit for the Human Rights Commission.

What do you see as crucial issues facing our community, and briefly explain why?

Through my public policy project in my Masters program, I am currently developing a city ordinance that will address gentrification for the City of Saint Paul. Much of my research was through the advice and expertise in Saint Paul's HREEO department. I believe affordable housing is the most crucial issue that faces our City. Nearly 100,000 households in the Twin Cities metro area pay more than half of their income. More that 20,000 of these families fall into homelessness each year. Gentrification will likely speed up the process where people will be "priced out" or forced out of their communities. A recent study from the Center for Urban and Regional Affairs (CURA) at the U of M, found that most of the communities of color in Saint Paul are currently going through gentrification or will be gentrified in the coming years.
