Revocation of Fire Certificate of Occupancy and Order to Vacate

Dear Property Representative:

Your building was inspected on April 28, 2025, for the renewal of the Certificate of Occupancy. Since you have failed to comply with the applicable requirements and the legislative hearing officer's orders, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code.

Compliance is required by May 15, 2025. An inspection will be made on May 15, 2025, at 9:30 am or the property vacated.

If found noncompliant, the property is to be vacated by May 28, 2025. A reinspection will be conducted on May 29, 2025, at 2:00 pm to confirm the property has been vacated.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

DEFICIENCY LIST

- 1. Throughout Sec. 40.06. Suspension, revocation and denial.
 - (a) Grounds for revocation. The fire code official may, in writing, issue a notice to the owner(s) and known interested parties of the city's suspension or revocation of afire certificate of occupancy issued under the provisions of this code, or deny an application therefor:(3) If it is found upon inspection of the fire code official that the

building or occupancy is in violation of provisions of this or other applicable safety codes, ordinances, rules and regulations.(4) If the owner, in a material matter, fails to comply with the regulations in section 40.09 of this chapter; or in situations where the fire code official after a good faith effort cannot identify an owner or interested party: -Due to long term non-compliance and failure to comply with the Legislative Hearing Officer's orders.

- 2. Throughout SPLC 34.09 (4), 34.33 (3) Repair and maintain the window frame. Window frames throughout building are rotted/damaged. This work shall require a permit. Contact DSI trades department at 651-266-8989.
- 3. Unit 6 Bathroom MSFC 604.1 Repair or replace damaged electrical fixtures. Electrical wiring, devices, appliances and other equipment that is modified or damaged and constitutes an electrical shock or fire hazard shall not be used. This work may require a permit(s). Call DSI at (651) 266-8989.-Bathroom light switch pops/crackles when turned on or off and light flickers. 3/28/25 UPDATE: Electrical permits need to be inspected and closed by the electrical inspector.
- 4. Unit 6 Living Room Window SPLC 34.09 (4), 34.33 (3) Repair and maintain the window frame. -Living room window frame, bedroom frames, and kitchen frame are rotted out. Repair or replace frame.
- 5. Unit 6 Living Room- Bedroom SPLC 34.10 (7), 34.17 (5) Repair and maintain the ceiling in an approved manner. -Large cracks in living room and bedroom ceilings are starting to crumble. This work may require a permit. Contact DSI trades department at 651-266-8989.
- 6. SPLC 39.02(c) Complete and sign the smoke alarm affidavit and return it to this office.
