## **NOTICE OF PUBLIC HEARING**

### **Sound Level Variance Jamaican Outreach 5K – Phalen Park**

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

#### **Description of Variance:**

**Location:** Phalen Park – Picnic Pavilion 1600 Phalen Dr.

**Noise Source:** Anderson Race Management has requested a sound level variance in order to present music and announcements for the Jamaican Outreach 5K at Phalen Park. The variance is requested at no specified sound level limit or distance, for the hours of 8:00 a.m. until 1:00 p.m., with a pre-event sound check at 8:00 a.m., on Sunday, June 30, 2019. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The Variance shall be for the hours of 8:00 a.m. to 1:00 p.m., with a pre-event sound check at 8:00 a.m., on Sunday, June 30, 2019. 2. All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:00 p.m. on the event date.
