Hello Amy,

I read this past week that city staff and the trash haulers in the community have reached an agreement that looks very encouraging.

I imagine you are hearing from both supporters and opponents as Wednesday's vote approaches. So I wanted to reach out (hopefully for the last time) to reiterate my support for the proposal to organize/coordinate city trash collection. I think the effort to organize will provide better service and position the city to make progress on a number of other environmental initiatives.

I'm also excited by a number of the details I've seen about the agreement. Especially that the new system will continue to have a place for independent haulers, and will allow for a small container (~35 gallon) with bi-weekly collection. We currently share our trash service with our neighbors, so some would have likely argued we stood to 'lose' by having the system organized. I certainly don't view it that way given that we'll have a small container/bi-weekly option. I wasn't able to find a hauler that offered that service when I looked for it prior to going the route of sharing with our neighbor. So despite some of the themes opponents have raised I didn't feel like an open system was offering us choices between options we wanted.

I raise that in part because I understand there is a desire to give some folks the option to opt out (which I presume means they could self haul/not have service). For what its worth I don't support that provision. I think the fact that many houses don't have service currently has resulted in illegal dumping issues -- that was a major problem in the ~9 years we were living in Frogtown. The proposal as it stands offers good options for those of us who recycle, compost, use organics drop offs and try and prevent waste. The negative consequences of an opt out option outweigh any potential benefit.

Anyhow, I think the city staff should be commended for this remarkable achievement. I can only imagine how challenging the negotiations must have been, but it certainly appears they've found a solution that will serve the city's residents much better and that haulers felt like they can live with.

I hope to attend the council meeting on Wednesday, but have to coordinate some pressing family obligations that may prevent that from happening. Either way, I'm sure you'll hear from some skeptics but please know that many of us support this effort.

Thanks for listening to my feedback now and over the past year or two on this issue. Good luck on Wednesday!

Hello. I am a constituent living on Prior Avenue in the Highland Park neighborhood. I am writing to encourage Councilmember Tolbert to vote against the resolution authorizing city staff to begin final negotiations with the residential trash haulers about standardization of services and trash collection days.

I believe this policy proposal to be a prime example of the phrase "a solution in search of a problem." Prior to this proposal, there was a citizen-led movement to have residents of a block or neighborhood all contract with one trash hauler, usually with one or more haulers offering discounts to secure this contiguous business. This local movement allowed residents to feel like they still had a choice of how trash disposal was handled, rather than having a solution imposed from the top.

As to the specific complaints prompting the proposals for city-organized residential trash collection, I believe most could have been resolved with less intrusion by the government. For example, an ordinance could be passed to require that trash collection in a particular area (designated by zip code, precinct, or other means) all be done on the same day, thereby eliminating the complaint of garbage hauler trucks going down alleys on multiple days. In addition, if a hauler did not already have enough customers in an area to justify sending their trucks in on that day, that hauler could arrange to switch

customers with a hauler who had a sufficient presence in that area, but an insufficient presence in another area. Again, a solution arranged by individual actors rather than imposed by government. While requiring all residential properties to have a trash hauler might seem a means to reduce illegal dumping, I'm not sure that an owner who doesn't arrange for this at the time of purchase of the property is going to be more likely to use a service they haven't missed before now. Finally, the provision of waste collection containers by the city will require the city to store many cans to accommodate people whose life circumstances change or whose cans are damaged by weather or vandalism. Since we currently have numerous private vendors who sell containers, I consider this new responsibility of the city to be a distraction from those areas where the city has a monopoly on the service or activity.

In short, I again urge you to vote against this resolution.

Our family has used Ken Berquist and Son disposal since our home was built in 1948. In the intervening 69 years Ken Berquist and later his son Jim have provided extraordinary service. We have been extremely satisfied with Berquist, value the consistent quality service provided for almost 70 years, and do not want to lose them as our service provider.

Under the refuse collection plan to be presented to the City Council our costs will increase by 33% or \$101.16 per year. Over half of this cost increase is the City's "administrative fee". The additional "benefits" of the pickup of a Christmas tree and three "bulk" items per year are essentially worthless to us and in no way compensate for the sharp increase in refuse collection costs. Additionally there is a good chance we may be saddled with another hauler.

Our family has never objected to the higher property taxes in Highland and view them as the trade off for the quality of life including Hillcrest Recreation Center, Highland Library, Highland Aquatic Center, etc. We do, however, strongly object to the City mandating refuse collection service providers and the steep cost increase associated with the City's proposed contract.

We are not alone in this and we join our neighbors who have expressed anger and frustration at the arrogant attitude exhibited by the City staff with respect to recycling and the proposed refuse collection contract. Conversations with City staff months ago expressing concerns about this proposed contract definitely gave the impression that this is a "done deal".

As a retired public employee living on a fixed PERA pension and social security our family does not need our collection costs increased by 1/3 with no payback or increase in service. Equally concerning is the probable loss of our longtime valued hauler. We would strongly urge you to vote against the proposed refuse contract.

They charged extra if the barrel cover was not down. They never cleaned up if garbage got strewn on the ground when making the collection. The rates were constantly rising. I finally found a local hauler, EME Garbage Removal, whose rates were much more reasonable. Also, they never leave trash on the ground, and they put my container back to the fence. I am very happy with them and would hate to see another local business being removed from the market.

The recycling company which is chosen by the City of St Paul makes many demands. The can has to be two feet from the other can, down to the alley, which is fine, but when they are done many times there is recycling laying all over the alley. Plus, sometime the container is way out in the middle of the alley, sometimes tipped over, and many time the lid is left open.

**I think the City of St Paul should let the citizens make their choice of the Garbage Hauler they would like to use.**

I do not have choices by other City services, and now are taxes are being raised once again for the fees for Right of Way, Alley, and Tree Services. I'm requesting more than just having the statement submitted. I want to be very clear about what I'm looking for. Please let me know if I need to submit more information or change plans in order to attend the Hearing see that this viewpoint is represented. (While some may think this is a little thing, to many this expense can mean a great deal.)

STATEMENT:

I have attached my statement to this email. Please confirm receipt. Also, please let me know if I should be providing a statement with my address redacted (I assume not redacted, since I'm proving I'm a resident; let me know whether that is the case).

PLEASE NOTE:

I am asking Jane to stand firm in asserting that residents should pay an amount similar to the one I currently pay. I was able to negotiate this rate by myself. Surely, the City, with the bargaining power of all of its residents, can negotiate a similar rate. All residents will be stuck with whatever deal is negotiated by the City - we won't have another option. Please do not allow the Haulers to gouge us because "they can" or because some Haulers have been doing so previously with some residents.

The push for organized hauling came from an affluent part of the City. Please keep in mind that not all residents can afford to pay more for their trash collection.

SOCIAL MEDIA CONVERSATIONS:

Notice has gone out to the neighborhoods via nextdoor.com. I have been having a conversation with Ward 7 residents about the upcoming

Public Hearing. While talking about the potential of a rate increase, here are a few of the comments:

- I'm on a fixed income. If it goes any higher, I'm not going to be able to afford it
- I have been here 16 years and paid for the disposal of 2 large items during that time. I will now be forced to pay for 3 every year!
- I wonder what this means for rates. Right now, if the price goes up, I call and ask for a deal because pickup is so competitive - I can usually get them to drop it back down to about 15/month.
- Right now I am paying \$15.82 a month, which comes out to \$189.84. We have a medium container. I am sure it will at minimum double when you consider that it will add into the Escrow which will then be included in my mortgage payment.
- With tax, etc., I'm paying \$14.42 per month for a small container. This is up from intro rate, which was a dollar less for the first year. Highland Sanitation.
- That's about what I pay Highland, too. It won't be that low once the city gets their fingers into it!
- It is always trouble when there is 1, especially big government, having monopoly on a dictated, needed service.
- They were taking input about a year ago & I submitted my garbage bill, along with contacting Ms. Prince. From her response back then, sounded to me like she was getting very little input & didn't think it was an issue in our district. Personally, I think the city has many more important problems that they haven't solved. But, that's modern day government for you.

Please inform us of Jane's position regarding this issue and whether she will be standing firm on keeping rates low.

PS: I have a dispute from some time ago with a Hauler who did not provide service to me but continues to send me bills me for that service. Should that Hauler be assigned to my area, I would expect that they would be made to provide service, without being able to demand a payment which I dispute. Is this something the City Council has addressed in negotiations? I feel it could become a problem for some residents, should they have a similar issue.

Jane and Stephanie -- I just took a look at the rates cited in the proposal (which I found attached to the City Council's Agenda).

Assuming the monthly rates found at pp. 3 and 4 are accurate, they seem reasonable EXCEPT for the fuel surcharge of \$3.49 per month. This amount is excessive and should not be allowed. Gasoline is a cost-of-doing business for these haulers. My current hauler does not charge a fuel surcharge and

this should not be allowed to be tacked on. Haulers' routes will be concentrated into specific areas, lowering the amount of gas they use. To suddenly tack on a gigantic fuel surcharge is a thinly veiled attempt to add to their profits. If anything, a fuel surcharge of \$.25 or \$.50 per household could possibly be seen as reasonable.

I also see that there is a letter from Summit Hill Association objecting to the short notice for the hearing. I agree completely with this objection.

They have 3 people (one in diapers) so the garbage production is HUGE. Basing it on # of people is faulty - how will you confirm that (my other neighbors have no fewer than 8 people in their 3-bedroom home) - and size of the home punishes empty-nesters like me.

In all other communities where I lived it was flat-fee.

I want to briefly chime in. I am mostly for the city providing disposal services, but as a single person household and my friend (neighbor) is as well, we have shared a single medium can for almost 10 years now. And rarely, like maybe a half-dozen times a year, do we even fill the can past half-way. No matter what the negotiated rate will end up being, for us, our rates will at the very least double, and possibly triple.

I think the rate should also be tied to the size of the household, or square footage of the house and not the fair market value or amount of street frontage. A small square footage will not produce as much trash because in general there will not be huge families living in small houses. This wouldn't be a perfect system, but it would be more accurate (in my opinion) than a purely tax base valuation. Maybe it could be a tiered valuation with base charge derived from taxable value, and usage amount on size of household?  
My two cents.

Julie, et al:

St Paul is the only community in which I have lived where the city did not provide disposal services, but service was provided with minimal cost and high convenience to residents. I, personally, believe this can be a good idea for the city **pending answers to questions like yours** but getting others to agree will require a great amount of change management, which will require clear answers and communication. I feel the City has failed in these two tasks. (I have lived in 7 different communities, with St Paul being the only one in Minnesota.)

We are also hearing similar concerns in other Nextdoor communities (since your neighborhood and mine don't "connect" you may not see those concerns.) This plan is very poorly supported as is. The main concerns is losing competitive pricing and a right to self-determine providers. Many others, like me, are concerned about the yard waste feature and a cost of including 3 large items per year.

My garbage bill doubled when Veolia was bought by a national hauler. When I decided to change to providers this year, and wanted to add yard waste pickup, the local providers said they don't provide it to my neighborhood. Oddly, they do provide it to other neighborhoods. I am forced to pay national rates just to have yard waste pickup because I live a mile from the yard waste site.. I pay approximately \$280 per year with an additional \$10/mo for yard waste season. Most times my garbage can contains one 13-gallon bag because I live alone and am gone frequently. Yard waste is nearly always full and the past three weeks I have had to put out additional bags.

Perhaps, since the City meeting overlaps with an also-important St Paul Police Community meeting, a few of us on the Eastside can meet tonight or tomorrow night, share notes and then divide and conquer the poorly planned input sessions.

I'm willing to locate a spot if we are all open to that. Our input is important to both these groups.

Council member Thao,

I read that the city is considering unifying garbage. This is great. Every few years I shop around for services. last month I redid the garbage rates, and passed the findings to my neighbors.

I used the list of haulers licensed in st paul, available on the city web site. and called each one for a quote. It took about 6 hours.

The sheet is based on my address 1077 portland ave, 55104.

I'm sending you the list so you can see the difference in charge from one hauler to the next, and have a better understanding of what is a fair charge. I've recently read that trash collectors aren't paid living wages.

I'm thinking that since:

- the haulers wouldn't be driving so much each day looking for trash,
- the collection would be more efficient, enabling more productivity for any particular truck.
- the efficiency would translate into higher profits for the haulers.

2

- which in turn should be better wages for the collectors,
- while keeping rates low for the city.

However Im thinking that the city may get fleeced.

Please take this rate sheet as an example of the variance in cost from one hauler to the next.

Also It might be valuable to see how long the recycling takes to collect a full truck, My recycling is roughly the same quantity as my trash.

If Eureka says it collects 300 homes a day ( a guess ) and a trash hauler does 150 in the current piecemeal way, the level of savings due to efficiency could be estimated.

Also, the prices listed are tax included, final prices. The city charges 28 or so percent tax ( for environmental fees, etc ) , on top of the state sales tax.

Mr. Bostrom, I am incredibly unhappy about the proposed organized trash pickup actively being discussed and negotiated. The proposed rates plus administrative fees mean that for my family of 3, we still have an increase of \$130 dollars a year in trash fees with this program. I am a current customer of waste management and have negotiated hard, but fairly, for my family's trash needs. I do not give one care in the world about a Christmas tree pickup (we went artificial) and the 3 bulk items a year are more affordable to bring to advance disposal where the first 400 pounds (typically more than 3 items) is a mere \$40.

I'm also deeply concerned about the increasing number of "city services" being mandated to go through the alley. After 10 years in my home, our alley was finally seal coated for the first time this summer. It is my understanding that is to happen every 5 years. It doesn't. I also, with other residents on my block, pay to privately plow our alley so that people have access to their garages over the winter. I'm more unhappy than I can express politely that the city is taking advantage of that resident generosity, something that happens all over the city, to suit it's own agenda and using it for recycling and now for trash. If you're going to provide, and in fact mandate, city services be done via the alleys, the city needs to be responsible for maintenance of that surface.

Our recycling pickup reliability has been sketchy at best. The process of that transition was horrid. The city residents do not deserve to go through that again with this new trash system.

And while I'm at it, have you driven around your ward lately? They skim coated roads in the most haphazard way this summer and it looks appalling. Drive down Duluth from Maryland to Case this week for a preview. Was it too costly to skim coat to the curb? I have no idea what the thought process was here but it is an eyesore.
