Me renting to them was my last attempt to save my house they stop paying rent before the heating was required I'm surrendering the house with my bankruptcy. We don't have to keep continuing I have medical issues I'm taking heavy drugs I can barely stay awake. I don't have any money after my bank accounts were unfrozen they took the money that was in there I am homeless living with a friend you can't get something that's not here they created the situation by not paying me rent so I could get it fixed right before October 15th when heat is required they have lived free and they are still running the heat because even though permits weren't pulled they know the Furnace was set up correctly. Either way I am not fixing anything because I have nothing. I was getting a loan from a friend to pay them to vacate and jowana sent an email saying she wasn't signing anything unless I took down reviews about their business and my friend backed out because she said she doesn't think they'll leave so I have made attempts to try and settle. They have been living for free they don't deserve anything and I have nothing for them. We could combine these or do whatever but the house is going in the bankruptcy and anything pertaining to it as well. I will not let anyone extort me not the tenants or their lawyer so whatever happens from now is out of my control. I told you all from the beginning I couldn't afford to fix it you're all forcing me to commit to something that I can't do now you know and have a better understanding of what's going on please update me and I have reached out to the some higher ups to inform them of the conduct and the disrespect that I've experienced with not only the courts but all so the fire inspector that called around telling others that my house is condemned. I've stated multiple times that I'm having medical issues and the court has disregarded it every chance it has I'm not going to die because you don't respect my doctors opinion.

Jowana is a criminal and if you like helping her kind manipulate the system fine but I give up on everything I just need a Resolution so I can stop worrying about missing court when I keep telling you I am I'll.


