Subject: Questions and Request: Reject "F4 Residential Mixed High" Density Ford Site plan, replace with "F3 Residential Mixed Mid" cap

Chris – I would like to thank you for taking the time to meet with us last Wednesday evening. Since that meeting, I have been talking with my neighbors, and researching the documentation provided, per your guidance. I have a few questions, and would very much appreciate your response.

What is Ford expecting, and what are they willing to support? Are there any agreements made with Ford? Specifically, was there an agreement made with Ford that if they bring the environmental code up to “residential” that we (or our elected officials) would support and promote what would seem to be the highest value driver of their property (the F4 Residential Mixed High) zoning within the site area? I still do not understand how all the public documents made available have recently changed to include high density, and “4,000” units, and how this became the de facto plan.

How are you planning to vote? Are you planning to support the current plan? As our elected official, I would like to understand prior to your vote (which will impact all our lives for many, many years) how you plan to vote. I strongly believe that the “majority” of your represented citizens do not want “high density” zoning, and the inherent risks that will bring to the livability, and overall property values in and around the neighborhood. I cannot state this strongly enough. The risk of “high density” does not outweigh any potential rewards of high density zoning (vs. medium). Personally, we have worked very hard to make our lifetime investment in this area of St. Paul, through several properties, and the potential downside of this zoning could seriously impact our financial well-being in a negative way. Not to put too fine a point on it, your vote (and your ability to influence your peers) will likely directly impact my family’s long-term financial security.

I believe that F3 Mixed Residential Medium would have a positive effect on the value of the neighborhood, if done right. We are not resistant to change. This view is shared by almost every single citizen that I have spoken to (over 50). If you are planning to support the current plan, I believe you owe it to your constituents to make that known, so that you can get a full appreciation of our (my) concerns prior to making your vote. I just want to make sure that you understand the intensity of the emotions that exist within your constituency on this matter, and I

don't believe that the number of, or intensity of, the supporters of high density are equal to that of those that oppose it. Without knowing your career aspirations, as an elected official, I think this could be detrimental to your career plans long-term. The concerns I have, and that are shared by ALL the people that I have spoken with, is that this is a "fait accompli", that somehow this is all pre-arranged, and the public hearings, etc. are just window dressing on decisions that are basically already made ... and that there is nothing we can do about it. I reject this on principle.

There is a fundamental difference for our elected officials between representing our people, and leading them. Sometimes leadership means taking an unpopular position. There are times when this may be necessary to impact positive societal change (EG: Civil Rights act). This IS NOT one of those times. This is an opportunity for you to be the voice of your entire constituency, and to represent what we want as a society, and as a community. There is an abundance of good that can come from a more conservative use of this space, with far less downside risk. Your vote is a decision that impacts us all. **This is an issue that will forge the electorate, one way or the other.** I strongly encourage you to take advantage of that opportunity.

I also appreciated the opportunity to discuss with you a bit the proposed development plans for the Ford site - a topic I'm sure you're quite tired of at this point. I do want to put in writing some of my thoughts on the topic.

I think there is a great deal of room for compromise on the subject. Having followed the planning process for years, in my opinion there are two areas of concern:

1. Citizen input

Yes, there have been countless hearings surrounding development plans. Having said that, I think residents of Highland Park have felt that their concerns and "wants" have not been heard. A better characterization of the situation is that perhaps we have been heard but ignored. The misrepresentation (letters being found in an inbox, etc.) of support/opposition has damaged the credibility of the planning process.

2. Density

All of us want bike paths, walking routes, mass transit, sustainability, affordable housing, etc. It is the level of density that is concerning. However, I think there is a great deal of room for compromise in the plan. If building height maximums could be brought down to the lower level of the range being proposed, I think most of us would be quite happy. I hope as the Councilmember representing Highland Park, there is a role you can play in the ultimate solution. Good luck with all that you have on your plate and let me know if I can be helpful in any way.

Subject: Support for Ford Site Plan

Now that the City Council is about to wrestle with the plans for the Ford Site, let us consider some actual facts and not hyperbole, misinformation, and downright lies put forth by the Neighbors for a Livable St. Paul.

First, the city's (and state's and country's) demographics are shifting dramatically. It's been reported that from 2020 to 2030, for every one person added to the metro area population of working age, 21 people over the age of 65 will be added. As a result of this aging population and younger people having fewer kids, the average household size is considerably smaller now than it was 20 years ago, and it's projected to decrease even more. Seniors are increasingly choosing to locate in dense, walkable neighborhoods since it decreases their reliance on cars and allows them a healthier, more social, environment.

Second, let's be clear about what's being proposed. The proposal is not for 10,000 housing units, it's for 7,000 or 8,000, and insofar as this is a zoning plan, it represents the maximum allowable density that could potentially come to fruition in 15 or 20 or 30 years. With regard to increased traffic, the information I've seen has been clear about assumptions for traffic increases. They've made it clear that they're not assuming everyone will suddenly bike or take transit. Rather, they're assuming most people will continue to drive and they've made a reasonable assumption that the restored grid will ameliorate increased traffic. Yes, Mount Curve will see more traffic but that mostly underscores how little traffic it sees now, not that it will be constantly congested when the Ford site is built out.

Third, more housing is desperately needed within city limits. While vacancy rates hover around 2%, rents are increasing and people are having a difficult time finding housing in the city. From an environmental standpoint, it makes far more sense to build housing within the city than to force people to move further out and force them to endure long commutes in less walkable places. And more housing equals more tax base, meaning that this development and others within St. Paul could eventually help stem high taxes in the city.

Dear Councilmember Tolbert,

We regret that we will be out of town on August 29th and so will be unable to attend the town hall meeting on the Ford Site Zoning and Public Realm Master Plan but we wanted to share some thoughts with you in our absence. We are 26-year residents of the Macalester Groveland neighborhood and we strongly support the singular opportunity before the City of Saint Paul to create a new 21st century mixed-use community of mostly multifamily buildings and commercial space for this site. We support this plan for a two key reasons:

- Economic – The City of Saint Paul has a vast amount of old infrastructure and a large share of its land base is tax-exempt property. The rapidly rising burden of maintaining and replacing this aging infrastructure falls on the shoulders of a very limited pool of property tax payers. The Ford Site (and other, smaller sites scattered throughout the City, such as the southeast corner of Snelling and St. Clair) are vital opportunities to substantially increase property tax payments to the city. We must not squander them on low-density developments.
- Environmental – On a per capita basis, multifamily buildings tend to use considerably less energy and water than their single family counterparts and the higher population densities they support make public transit much more viable. In addition to these benefits, the Ford Site Plan would include solar rooftops, innovative stormwater management and the daylighting of the Hidden Falls Creek – all resulting in a remarkably sustainable urban community that will improve the quality of life for St. Paulites.

We understand that you are receiving considerable pressure from some vocal constituents that would prefer to see the Ford Site redeveloped into a low-density circa 1950s suburban neighborhood. This alternative vision for the site is not economically or environmentally viable and thus not sustainable. We encourage you to stay the course for the realization of an innovative new 21st century community in Saint Paul.

I wanted to ensure that my concerns were heard as I will be unable to attend the meeting this week at Gloria Dei Lutheran Church due to a prior commitment. I have been a resident of Saint Paul for more than 45 years, I was raised in Highland park. I grew up near Randolph and Snelling. Saint Paul is my home and have several dozen friends who live in this area and in your ward 3. I have yet to find a single person who supports the existing plan as outlined. Again, no one I know living in St. Paul supports the current plan. These are all voters and tax payers living in your ward 3 with children in your schools and attending churches in your ward. These are active voters who are closely watching to see if you will protect their interests. It is important for you to understand that if you choose to ignore the interests of those you represent, in favor of a small minority of developers, your political career is over. I understand that the land once occupied by the Ford plant is valuable and needs to be utilized for the benefit of Saint Paul. However, High density housing is not appropriate for this area. The roads in that area are already horribly overcrowded. I grew up working at Lunds in Highland park back when it was still Applebaums. Over the years traffic in that area has gotten steadily worse without any real improvements. It has gotten to the point where I simply avoid travel in that area whenever possible because it has gotten so congested already. I will only shop Highland Park now during off peak hours because the Ford Prkyway and Cleveland & Ford and Cretin intersections are horrible. Dear Councilman, Thank you for your reasoned response to the draft plan for the Ford Site.

While I recognize my neighbors in Highland find change difficult and disagree with elements of the plan, I applaud the City staff for the open and inclusive process. As a former district council member in another part of St. Paul and a former department director, I know not all planning efforts have been this well done. My experience says this plan strikes the right balance between green space, commercial development and housing. As a strong supporter of many years of the rules for the river and MNRRA, despite some misgivings about the height proposed for the buildings the furthest away, I recognize the importance of density to make this an attractive and viable project for development. I believe some of the neighborhood reaction, almost hysteria, about density and traffic is overstated and has been well addressed.
