RESOLUTION APPROVING THE FORGIVENESS OF PAYMENTS OF PRINCIPAL AND INTEREST DUE IN 2015, 2016 AND 2017 FOR AN INTERFUND LOAN WITH PUBLIC WORKS DEPARTMENT FOR THE

PARKING METER REPLACEMENT PROJECT

Requested Board Action

Approval from the HRA Board to adopt the attached resolution that forgives payments of principal and interest due in 2015, 2016 and 2017 for an Inter Fund loan with the Public Works department for the Parking Meter Replacement Project.

Background

In December, 2011, as part of the 2012 Budget, the HRA and the City adopted budgets that included a \$1,500,000 loan to Public Works from the HRA Parking Enterprise Fund for the Public Works Parking Meter Replacement Project. A Record of Inter Fund Loan was executed on February 22, 2012.

Public Works completed the meter replacement project and on 4/1/2013, the HRA Parking Enterprise Fund advanced \$1,392,359.92 to public works for repayment with interest at 3% per annum. The payments commenced on 12/1/2013 and were to continue each December 1 until the loan was fully repaid on December 1, 2017. A payment in the amount of \$327,044 was made on December 1, 2014, resulting in an outstanding principal balance of \$764,969.33.

Approval of the resolution would result in the forgiveness of principal of \$764,969.33 and interest of \$41,205.01 for a total receivable of \$806,174.34.

Budget Action

The HRA 2015 Budget, adopted on December 10, 2014, included the reduced revenue from the loan repayment due in 2015 in the amount of \$327,044. The amounts due in 2016, of \$327,044, and 2017, of \$152,086, are not yet budgeted; therefore, no budget action is necessary.

Future Action

Financing Structure

The loan forgiveness will result in the release of a like amount of revenue in the City's general

fund budget, which in 2015 will benefit the Library budget to assist in the purchase of materials

and to assist in the staffing of Sunday and evening hours at various library locations.

Current estimates prepared by PED staff indicate the Parking Fund will be able to sufficiently

cover all expenses (operating, capital, and debt service) with the reduced revenues, as well as

fully fund various reserves. The cost to the Parking Fund will be the ability to otherwise spend

these funds outside the parking system to further economic development goals.
