Agenda Item: Appeal of Mr. Delbert Moore regarding 134 Maria Avenue

Dear Councilmembers and Legislative Hearing Officer:

I am a very concerned neighbor of the property owned by Delbert Moore at 134 Maria Avenue. His Certificate of Occupancy was revoked for good reason. This property was placed on the Vacant Buildings Program and Mr. Moore is appealing this. 134 Maria has been a problem property since I moved into the neighborhood in 2000. It is my understanding that he will be attending the meeting as well as several of his tenants. One tenant Mr. Robert Daniels III will make a case that he is dying of terminal cancer and should not be displaced at this time of year. I am attaching a copy of the Police Report showing all the calls to this property since 2000. A good majority of the calls have been since Mr. Daniels moved into the duplex.

I would ask that the City Council strictly <u>rule on the facts</u> of this property and why this matter is before you, not to rule based on a tenant who is facing eviction due to his landlord's delinquent actions.

Facts:

- Certificate of Occupancy revoked 11-10-14 and placed as a Vacant Building Category II as a result of additional people living in the basement illegally and report that they were using the property as a Triplex when it is only registered as a Duplex.
- Parks Summary Abatement for garbage/rubbish 11-6-14
- Parks Summary Abatement for garbage/rubbish 10-31-14
- Additional Trash Container ordered by city 10-8-14
- Park Summary Abatement re garbage/rubbish 10-1-14
- Work Order-Hauler re garbage/rubbish 10-7-14
- Summary Abatement re garbage/rubbish 9-18-14
- Vehicles ordered to comply by 8-25-14; Vehicles Abated 8-27-14
- Summary Abatement re garbage/rubbish 8-20-14
- Certificate of Occupancy follow up on Certificate of Occupancy folder approved with corrections 8-7-14 (later revoked on 10-28-14)
- Parks Summary Abatement re garbage/rubbish 6-10-14
- Certificate of Occupancy approved with corrections on 8-7-14; there was a list of 28 corrections needed with abatements after 3 inspections (again revoked in October)
- Complaint about porch being re-built with no Permit pulled (3-25-10); Permit later pulled in August, 2010 (listed as Under Review)
- Building Permit pulled in August 6, 2009 with corrections required and it expired.
- Complaint on 7-27-09 regarding dangerous work being done converting porch to 3 season porch DSI states Under Review.
- Building Permit was pulled on 6-16-08 and closed on 7-8-09 expired due to no activity in one year.
- Certificate of Occupancy for 2010 with corrections required. It appears that things were abated after 4^{th} inspection. Correction Orders issued 8-11-10 and it states items were abated -3^{rd} inspection.
- Parks Summary Abatement re garbage/rubbish 10-26-05.

As you can see above, it appears that Mr. Delbert Moore squeaks by on some of the Certificate of Occupancy Certificates. He always seems delinquent in fixing the problems of the property and has been abated quite a few times. As a concerned neighbor I feel that this property should remain on the Vacant Building program. Mr. Moore will try and smooth talk the Council into turning a blind eye to things as he has done in the past. Neighbors have attempted many times to have conversations with Mr. Moore about this property, but he is unwilling to work on it. As you can see garbage accumulations and junk has been a problem for years. Personally if a Landlord cannot install a smoke detector for his tenants as required by the city and the city has to inspect the property that many times to see if he installed it and then did an abatement, he is not deserving of receiving a Certificate of Occupancy to house tenants and collect rent.

There have been threats made by his tenants to neighbors and as a result we are fearful of attending this meeting. We wrote emails to the Legislative Hearing Office for the November 4th legislative hearing and as a result have received threatening emails, phone calls, and pounding on our doors by his very upset tenant. Several neighbors also found sheetrock screws in front of their garage and one neighbor's car and garage were broken into. Retaliation for appearing at the City Council Meeting on November 19th is a very strong concern for most neighbors.

Please take into account our concerns and <u>rule strictly on the facts regarding Mr. Delbert Moore and his property.</u> Please do not rule based on a plea from tenants about being displaced because Mr. Moore has become a slumlord. Thank you.
