Any electrical work in the building must be done by a licensed electrician under permit
- 2. Unit #3 - SPLC 34.10 (7), 34.34 (6) - Repair and maintain the walls in an approved manner.
- 3. Unit #3 - SPLC 34.10 (7), 34.34 (6) - Repair and maintain the ceiling in an approved manner.-
- 4. SPLC 34.08 (4), 34.31 (2) - Exterminate and control insects, rodents or other pests on all exterior areas and in accessory structures.-Contact a licensed exterminator to exterminate for bees.
