**NOTICE OF PUBLIC HEARING**  
Sound Level Variance  
ALS Super Hero 10K/5K – Raspberry Island

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

**Description of Variance:**

**Location:** Raspberry Island, 2 Wabasha Street

**Noise Source:** Anderson Race Management has requested a sound level variance in order to present music and announcements for the ALS Super Hero 10K/5K Run at Raspberry Island. The variance is requested at a sound level limit of 110 decibels (dBA), at no specified distance, for the hours of 8:00 a.m. until 11:45 a.m., with a pre-event sound check at 7:30 a.m., on Saturday, April 21, 2018. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The Variance shall be for the hours of 8:00 a.m. to 11:45 a.m., with a pre-event sound check at 7:30 a.m., on Saturday, April 21, 2018. 2. All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:45 a.m. on the event date.
