## **NOTICE OF PUBLIC HEARING**

### **Patrick McGovern's – St Patrick's Day Events March 14 and March 17, 2015**

TO: West Seventh/Fort Road Federation

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

**Description of Variance:**

**Location:** 225 7<sup>th</sup> Street West

**Noise Source:** Patrick McGovern's has requested a sound level variance to present amplified music in an enclosed tent with use of a sound system for St Patrick's Day Events on Saturday, March 14, 2015 and on Tuesday, March 17, 2015 at 225 7<sup>th</sup> Street West. The variance is requested for the hours of 3:00 p.m. to 12:00 (Midnight) on Saturday, March 14, 2015, and from 3:00 p.m. until 12:00 (Midnight) on Tuesday, March 17, 2015.

The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 3:00 p.m. to 10:30 p.m. for the St Patrick's Day Events on Saturday, March 14, 2015, and from 3:00 p.m. until 10:00 p.m. on Tuesday, March 17, 2015. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured inside the tent at the wall opposite of the sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:30 p.m. on March 14, 2015 and no later than 10:00 p.m. on March 17, 2015.
