I did just want to note I neglected to include in my letter that the Council Public Hearing for this matter is scheduled for the day after the Legislative Hearing (January 14), on January 15.

*please note this time is during your appeal timeframe. If you think you may wish to contest by phone, I would suggest signing up and you can always choose to not do so. If contesting in person no prior action is needed.
