Commercial Corridors Program: Recommended Changes

January 2026



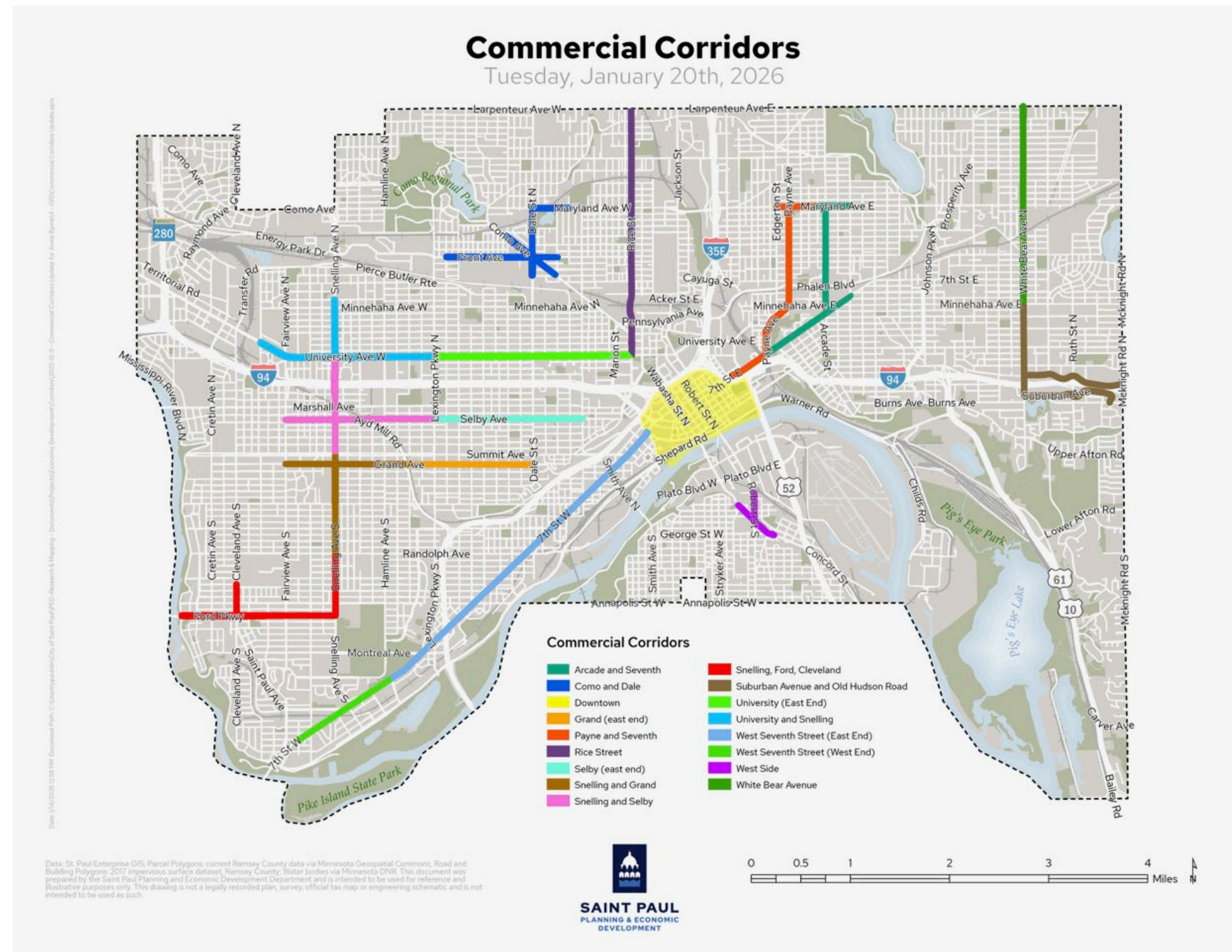
Overview of Requested Changes

- Corridor organizations were asked to provide any requested changes
- Seven requests were submitted regarding:
 - Geography
 - Grant size
 - Flexibility of grant use for operations
- Staff considered all requests and recommends changes to corridor geographic boundaries and grant size. In addition, we recommend guidelines include language that allows some flexibility when approved on a case-by-case basis.



Geography Changes

- Corridor boundaries will be extended to include additional businesses on the following three corridors:
 - Ford Pkwy: Cretin boundary extended to Mississippi River Blvd
 - East 7th and Arcade: Arcade boundary on 7th extended to Forest
 - Como and Dale corridor extended to include a few blocks past the existing boundaries on Como and Dale, and to include a few block of Front Ave.
- The Smith Ave corridor has a relatively small number of businesses and a large percentage of residential land use; we recommend removing this corridor.





Award Size Feedback and Recommendation

- Feedback was provided that it is not equitable to award corridors of such different sizes the same amount of funding.
- Corridor size, number of business, and land use were evaluated to categorize corridors:
 - Medium: less than 300 businesses; 10 corridors total
 - Large: more than 300 businesses; 7 corridors total
- Corridors in or adjacent to Areas of Concentrated Poverty (ACP) will continue to receive a higher amount.
- Smith is an outlier with 74% being residential and just 38 businesses (the corridor average is 247); therefore, Smith is considered a micro-corridor and we recommend it no longer receive an award.

Other Recommended Guideline Updates

- Language will be added to the Guidelines that allow for minor programmatic corridor specific changes, which will follow the CAO Amendment Process. This will allow flexibility if needed to be strategic and respond to unique circumstances in a timely manner.
- The updated guidelines will become Program Guidelines, and similar to STAR Guidelines, will not require annual updates but will be updated as needed to incorporate approved changes.
- Operational support was determined to be an ineligible use of business subgrants. This use will be removed from guidelines.



Final Recommendation: Name Change

- The Commercial Corridor Organization Assistance Program (C-COAP) is more complicated than necessary.
- It is recommended we rename it:

Saint Paul Commercial Corridors Program

This is already in alignment with the logo.
