**NOTICE OF PUBLIC HEARING**  
**Sound Level Variance – Fast & The Furry**  
**Kelly's Landing at Harriet Island**

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

**Description of Variance:**

**Location:** Kelly's Landing, Harriet Island

**Noise Source:** Uptempo Races has requested a sound level variance to provide the use of a sound system for music and announcements at Kelly's Landing, Harriet Island for the Fast & The Furry event. The variance is requested at a sound level limit of 90-100 decibels (dBA) for the hours of 8:00 a.m. to 12:00 p.m. on Saturday, May 21, 2016. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 8:00 a.m. to 12:00 p.m. for the Fast & The Furry event on Saturday, May 21, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:00 p.m. on the date of the event.
